PCG security lapse allows interloper to attend Feast

ICHITA, Kan.—I quietly asked a man standing outside a church-convention business office a biblically suggestive question: "I

was a stranger and you took me in?"

His answer was a disappointing shake of the head. No, he would not let me attend the Feast of Tabernacles, even though his group considers



it a commanded annual assembly for believers in God.

We stood inside Armstrong Auditorium in Edmond, Okla., the showcase building of the Philadelphia Church of God (PCG), on Sept. 19, 2013.

If I had purchased a ticket to one of the auditorium's artistic events, there probably would have been no issues. But attending a "free" worship service on a Thursday morning clearly was another matter.

Only baptized members of the Philadelphia Church of God can attend," the man told me.

But there was something he didn't

know. The Feast of Tabernacles had begun the night before, and, in a raritv for the PCG, an outsider had been allowed inside the auditorium's main hall for a service from start to finish.

Driving down I-35

I hadn't traveled to Edmond, the site of the PCG's headquarters, to rescue someone from what some consider an oppressive and spurious church.

I wasn't there to recruit people away, or even cry aloud in the auditorium lobby as Jesus might have done in John 7.

Armstrong Auditorium simply was the closest Feast site to my front door, and my job situation allowed me to attend only on the holy days specified in the book of Leviticus, along with a

It was my desire to worship God. But I drove down Interstate 35 well aware of what might happen.

Watch out for Laodiceans

The PCG has gained a reputation as being far more restrictive than the old Worldwide Church of God ever was.

Members are barred from all contact with relatives who are not PCG members, even those attending other Sabbath-keeping groups

In a sermon at PCG headquarters on Dec. 5, 2005, Pastor General Gerald Flurry explained the attendance and disfellowship policy involving "Laodi-



Church of God member's 10-tribes writings said to influence recent Glenn Beck prophecy commentary

God member and author Steven Collins was shocked when conservative commentator Glenn Beck announced recently he believes America was founded by descendants of 10 of the 12 tribes of Israel.

Founded 1997

Mr. Collins was amazed but pleasantly surprised to learn that someone as famous as Mr. Beck seemed to be endorsing what Mr. Collins has been saying for years.

"Glenn Beck Steven Collins shocked a lot of peo-

ple," Mr. Collins told THE JOURNAL, when he devoted one of his widely watched video programs to announcing that he now believes the U.S.A. was founded by the migrating descendants of the 10 tribes of Israel.'

Some of the writers of news articles about Mr. Beck's announcement (inCollins' Web site and books "as being a major support for Beck's belief, Mr. Collins said.

No one contacted Mr. Collins before writing their stories, he said, but they quoted from his blog post on the subject at his Web site.

This may be the first time the 10tribes truth was dealt with seriously in a major Web site and espoused by a major U.S. news figure," he said.

As a result of the unexpected publicity, Mr. Collins' Web pages recently attracted 1.1 million hits and visitors from 137 nations.

His original book, The "Lost" Ten Tribes of Israel ... Found! saw its four printings sold out several years ago but is still available in English as a downloadable E-book at his Web site and as an Amazon Kindle book.

The discussions about Mr. Collins' writings on prophecies focusing on the descendants of the 10 tribes invariably mention "British-Israelism," he said, and he's not too happy about that. terization," he continued. "The British-Israelists of the late 1880s were just one branch of people who believed that doctrine.

"As my books note, a U.S. pastor named F.E. Pitts presented this same belief to a joint session of the U.S. Congress in 1857 before there were any British-Israelites as far as I know, and a transcript of his message indicates he was anti-British.

"He told Congress the U.S.A. would be the great end-time rival of Russia—according to Ezekiel 38-39—and he even stated the Jews might have a future homeland in Canaan according to biblical prophecy." A fulfillment of

from there. Discussions among us led to a proposal to charter buses rather than for us country folk to risk the hazards and hassles of dealing with New York City traffic snarls.

So I made arrangements, and we chartered and filled two 49-passenger buses. All went well on the trip down.

Upon our arrival at the hotel and after we unloaded, a police officer came along and told the driver he couldn't stay parked at that location. He would have to move on and park elsewhere for the duration.

The driver responded to the cop that the bus had a transmission problem and he didn't dare move it. So the bus remained parked where it was for the following four hours.

There was no transmission problem. The driver lied. I heard him, but did nothing about it.

Several hours later we boarded and did our head counts. All seemed fine.

The bus moved forward a few hundred feet, then there was this grinding noise under the bus's rear end.

The back end lifted half a foot, we heard more clunking, then it dropped back and the bus went out of gear to move no farther.

We had moved forward just far enough to stop broadside across the busy Sixth Avenue, a multilane, allone-direction main thoroughfare in midtown Manhattan.

It was 5 p.m., the heart of rush hour. We were blocking the traffic and threatening to snarl traffic in all of the surrounding area. Circumstance had made our driver's excuse a reality.

Can we say be sure your sins will find you out?

So 15 of us dress-suited men pushed the bus forward to the nearest curb. There we stayed until the home agency could rush another bus the 135 miles to rescue us.

It was five hours before we were picked up for the return home. We soon learned that the replacement bus had no comfort facility.

The point here is that sometimes our fibs can turn into self-fulfilling prophesies. Lesson learned.

Ezekiel: Sins of Sodom were not about sex

AYETTEVILLE, Ark.—In appealing to the Bible for a code to

govern our sexual behavior, we must be careful how we employ that book in arriving at a standard that comports with God's will.

Many people have cited Scripture as the source for their beliefs about sexual mo-

rality. But a closer examination of some of those beliefs reveals a superficial and narrow understanding of what

that book has to about the topic.

In fact, when we focus on all of the scriptures dealing with the subject we are hard

pressed to arrive at a coherent and reasonable standard for human sexual

OT accepting of polygamy, slavery, misogyny

For starters we would have to address the Old Testament's apparent endorsement of polygamy, slavery and misogyny. After all, Jacob had two primary wives (Leah and Rachel) and two secondary wives (Bilhah and Zilpah).

King David had many wives and concubines (2 Samuel 5:13).

Solomon had 700 wives and 300 concubines (1 Kings 11:1-3).

How do we square those statistics with the principle of marriage between one man and one woman?

Is monogamy really God's standard? Did God regard slaves as the sexual property of their masters? (Genesis 16:3; Deuteronomy 15:12-17; 20:11, 17).

Wasn't a woman regarded as "unclean" during her menstrual period? (Leviticus 15:19-28).

Did God regard women as the property of their husbands? (Exodus 20:17).

Or does He regard them as His property only in the sense that everyone is His property? (Exodus 19:5; Psalm 50:12; Ezekiel 18:4).

Volatile administration

If we are fair in our assessment, I believe the biblical and historical records demonstrate that Christians have adopted erroneous ideas and teachings on human sexuality.

It is also apparent that these errors have resulted in much unnecessary pain and suffering for all of us.

In short, many of the beliefs, thoughts and deeds we have traditionally labeled as sin are not sin. Rather, sexual desires and relationships are a natural and wonderful part of being human.

Moreover, God designed us as sexual beings as a way to express our love for each other, enjoy each other and perpetuate the human race on this planet.

Two problems with sex

big problems with the traditional Judeo-Christian teaching on sex:

■ It doesn't encompass the entirety of Scripture.

■ Most Christians find it impossible to adhere to such a standard.

Thus, by clinging to these false notions we set ourselves up for failure and misery and for exposing our belief system to charges of inconsistency and hypocrisy.

God's truth, however, is not subject to failure or attack. God designed the human body (Genesis 1:27), and we learn from Scripture that God viewed

the descendants of the 10 "lost" tribes of Israel, then it should be possible to design a study to demonstrate the scientific validity of such a theory.

The study of genealogy has long been popular, but now genetic analysis allows us to study ancestry beyond just written and oral records and archives.

DNA research into migration patterns of ancient populations has come into its own.

Miles and miles of millennia

For example, National Geographic's Genographic Project, eight years old, uses advanced DNA analysis "to help answer fundamental questions about where humans originated and how we came to populate the Earth."

Just recently, three studies employing such research were featured in popular news media. They describe some of the tools scientists have at their disposal to determine with considerable accuracy the movements across the miles and millennia of multiple peoples.

Different DNA lineages

According to National Geographic's project, one study provided evidence that "the people who lived in Central Europe 7,000 years ago had different DNA lineages than those that lived there 5,000 years ago, and again different to those that lived 3,500 years ago.

"Thank You for my new baby sister—

but I asked You for a puppy!"

Are we the lost tribes?

It showed definitively that from 5500 B.C. to 1500 B.C. the region that is today Germany saw at least four stages of significant migration and settlement. The stages were highlighted by marked shifts in the genetic composition of the populations in the region.

Researchers focus on mitochondrial DNA (mtDNA). This type of DNA is passed down, almost unchanged, from a mother to her children, thereby allowing geneticists to probe the maternal histories of populations.

Mutant sharings

By studying the mutations or changes in mtDNA sequences, researchers have been able to develop a record of maternal ancestry and to group different mtDNA lineages together based on shared mutations.

Another recent study focused on the ancestry of Ashkenazi Jews who dispersed into Central and Eastern

Analysis shows that the Jews who left Palestine 2,000 years ago

were mostly men without wives.

Europe in the early Middle Ages. Their ancestors migrated from Pal-

estine after the destruction of the Second Temple in Jerusalem in A.D. 70. Researchers analyzed mtDNA se-

quences from people across Europe, the Caucasus and the Middle East.

Their analysis found that, "in the vast majority of cases, Ashkenazi lineages are most closely related to southern and western European lineages, and that these lineages have been present in Europe for many thousands of years."

In other words, the results show that the Jews who left Palestine 2,000 years ago were mostly men without wives.

The proof is in the testing

"They seem to have married with European women, firstly along the Mediterranean, especially in Italy, and later (but probably to a lesser extent) in western central Europe,"

"Malala, now 16 and living in Birmingham [England], tells here in exclusive extracts from her new book how the Taliban robbed her of her smile but failed to take her spirit."

Schoolgirl's diary

Malala burst onto the international scene four years ago when an article titled "Diary of Pakistani Schoolgirl" was posted at bbc.co.uk on Jan. 19, 2009.

Private schools in a northwestern section of Pakistan had been ordered to close due to a edict by the Taliban banning girls' education.

It was reported that militants seeking to impose a strict interpretation of Sharia law had destroyed about 150 schools over a year's time.

- "Friday 9 January: The Maulana [Maulana Shah Dauran, a Taliban cleric who announced the ban on girls attending school] goes on leave?

■ Wednesday 14 January: I may not go to school again.'

■ "Thursday 15 January: Night filled with artillery.

Her public descriptions of what was happening in Pakistan were not appreciated by the Taliban.

Shot in the head

Members of the Taliban have a history of making threats against people, but not usually against teenage girls. In her book, Malala describes how members of the Taliban shot her in the head.

Here are excerpts: 'The day everything changed was Tuesday. October 9, 2012, three months after my 15th birthday . . .

"We had been getting threats all year. Some were in the newspapers, some were notes or messages passed on by people. "The Taliban had never come for a

girl and I was more concerned that

they would target my father as he was always speaking out against them. "A close friend of his and fellow campaigner had been shot in the face and I knew everyone was telling my

father: 'Take care, you'll be next.'

'Who is Malala?'

"When our bus was called that afternoon, the other girls all covered their heads before emerging from the door and climbing into the white Toyota van with benches in the back . .

N THE LAND OF THE CHALDEANS BY THE RIVER CHEBAR—Today I took a strange trip. I was taken—at least it felt that way—in some sort of flying chariot.

I was seated in the device quite comfortably. The chariot floated gently over the land. I was transported swiftly through the air.

I had no control over where the chariot was flying, but I wasn't afraid. I felt strange knowing I was not in danger of falling out of the chariot, even though I had never before ridden in a vehicle such as this.

The ride was pleasant because the hand of the LORD was upon me, and I was being carried out in the spirit of the LORD.

I alighted in the midst of a valley that was full of—of all things!—bones. The chariot circled around and caused me to pass by the bones, and, behold, there were thousands of bones in an open valley. And, lo, they were very dry.

The trip

I am well acquainted with the Eternal. He has spoken to me many times, but this was the first time I found myself riding 15 or 20 feet above the ground.

I glided over a giant valley. I don't know how big it was, but it was perhaps 30 or 40 miles wide.

I was deep in my thoughts and a question took me by surprise. I had no idea of the answer, but the question was: Can these bones live?

As far as the eye could see

I didn't know what to think. Bones scattered as far as the eye could see? What could I know about such things?

I had the feeling that the Lord GoD would answer His own question. He was intent on enlightening my ignorance. After a silence He said to me:

"Prophesy to these bones, and say to them, 'O dry bones, hear the word of the LORD! Thus says the Lord God to these bones: "Surely I will cause breath to enter into you, and you shall live. I will

I was stunned by this direct order. I have carried out other requests of the LORD. But to speak to an audience of ancient, dried-out bones? How does this make any sense? How could the bones hear anything I would say to them?

Panoramic view

I was still hovering over the valley of the dry, dead, white bones when I gently came to rest on a small hill that afforded me a panoramic view of the immense valley around me.

I still had no idea how I would get back to my family, but I was not concerned or afraid. Something was reassuring and comforting about the presence of my divine Host.

I composed myself, straightened up and took cover behind a rock. But I prophesied as I was commanded.

As I was speaking I heard—and felt—a sound: a noise that grew into an unnerving rattling. The bones were coming together, bone to bone, skeletons! My words were having a strange vivifying effect on the bones!

The rattling continues

What in the world was going on? It seemed that in a twinkling of an eye the whole valley was astir. I heard the bones rattling and saw them convulsing. It sounded as if immense quantities of small pebbles were shaking and making a racket inside a huge, covered wooden box.


Beginning to perceive

This was the PCG's opportunity to show if that policy was still in effect.

Avoiding offense

I admit I didn't attempt to register in advance. I didn't want anyone in Edmond to know an outsider was coming and prepare a special public-relationsstyle welcome.

To avoid potentially offending people, I even removed almost all United Church of God materials from my briefcase in advance.

Wearing the proper suit and tie, I followed the PCG parking crew's guidance to a spot west of Armstrong Auditorium about 25 minutes before the customary 7:30 p.m. starting time.

Two door greeters welcomed me into the lobby while someone wearing a security badge stood well inside. He apparently, at that moment, was distracted with someone else and allowed me to walk right in.

During several minutes in the lobby, I admired a display of Middle East archaeology. A timeline along the walls dated it from before-Christ antiquity to recent Jerusalem trips by Mr. Flurry.

Several examples of items collected in the PCG's Armstrong Foundation's "big dig" were displayed as well.

Have a seat

I was not at all surprised to find a large portrait of Herbert Armstrong. It didn't face the lobby but was hidden on the opposite side of lettering declaring the building is dedicated to "the Great God."

Unlike the Ambassador Auditorium in Pasadena, Calif. (which once had a bust of Mr. Armstrong in the basement), a large encased Bible actually sits below that dedication in the Armstrong Auditorium. It was opened to Jeremiah 38.

It soon was time to enter the main hall, and I followed other people in.

"Are you looking for a place to sit?" an usher asked without any other question.

Very nice building

He helped me find a great seat with little difficulty: the middle of the ninth row of the main floor, directly in front of the lectern. It indeed was a top-quality building in appearance.

A bit surprisingly, the 823-seat auditorium wound up with empty seats down front on the opening night of the Feast.

After I spent a few minutes sitting quietly and marveling at my situation, a

man to my left shook my hand. He told others sitting nearby about how seemingly "everyone who moves to Florida gets suspended [from the PCG] and never comes back.'

A male college student wound up sitting to my right with a laptop, ready to take notes on the sermon.

No recording allowed

The unnamed song leader made it clear during opening announcements that, while picture-taking was allowed almost everywhere (a change from Ambassador Auditorium, which restricted such things), no audio or video recording was allowed of any PCG messages.

Copies wouldn't even be sent to congregations after the Feast.

People from other Church of God groups might have felt right at home with the opening night of the Feast in Edmond, at least with its format.

There were three Dwight Armstrong hymns from a version of the old purple hymnal (updated with a PCG logo on the cover), followed by an opening prayer.

Nice special music

There were lengthy announcements about Feast rules, including an ominous note that only people wearing Feast badges were allowed inside the building.

I wasn't wearing one. An old one from prior Feasts I had attended would not have worked, because the PCG badges had a big picture of the Armstrong Auditorium on them.

After a flawless presentation of special music by a Feast choir, the main opening-night message was a video sermon by Pastor General Flurry.

attempt to purchase the old Ambassador College campus in Bricket Wood, England, is "going slower than we would like." He gave no other details.

Raising the universe's ruins

Mr. Flurry said the future, which will include "raising the ruins of the entire universe," promises to be "more beautiful than Herbert W. Arm-

strong College.' Armstrong College (AC) was visible three times during his message, thanks to an overhead helicopter camera, with emphasis on Armstrong Auditorium and the Armstrong Foundation office across the driveway.

He revealed at one point the auditorium cost "upwards of \$25 million," including landscaping.

"Where's your badge?" a man asked as I approached the door. I was directed toward a registration

With that, I turned and walked across the lobby without an escort, tempted for a moment to blend into the crowd and try to get into the service anyway, as Jesus

might have done long ago. Instead I stepped out the stage-left door and walked to my car. As I walked I did something I can't recall ever doing at a religious meeting before. I shook the dust off

my shoes.

After driving home, I joined in the United Church of God webcast from Bend, Ore., for a couple of days.

Then for the weekend part of the Feast, I drove $2\frac{1}{2}$ hours in the other direction to a different group's Feast site.

Lyons Bible Study Group

I'd left an online question and voicemail message with the Lyons Bible Study Group about my possibly attending but had received no response. So this was a site-unseen trip of speculation as well.

Yet an amazing thing happened when found the group's site: an unmarked campground shelter near Lake Wilson in north-central Kansas. The 25 or so members welcomed me like a long-lost relative

They fed me several times, allowed me to join in interactive free-flowing Bible discussions and even let me lead a closing prayer after a 41/2-hour discussion on Sabbath afternoon (including a one-hour dinner break).

Different direction

Several of the group members admitted they had also split from Worldwide their path clearly went in a different direction from the PCG's.

The tone of the discussions I attended was more Messianic and Hebrew roots

Pork bologna was available for those

who preferred it. A few of the members openly swore, smoked and chewed tobacco.

And I wound up being the only one wearing anything approaching a suit and tie.

The difference between the two Feast sites I visited was like night and day. I offer them to you and ask: Which one comes closest to reflecting the example of Jesus Christ?

More Feast reports are scheduled to appear beginning in the next issue of THE JOURNAL.

To avoid potentially offending people, I removed almost all United Church of God materials from my briefcase in advance.

It apparently was the first of at least three videos shown at PCG Feast sites because he talked about "other messages" several times.

I should have asked him what "like mind" meant. But I think I already knew the answer. He probably would have given me the "Elijah question," asking if I believed Herbert Armstrong was the end-time Elijah.

answer to the Elijah question was yes. "You've got to work on that," the manager told me about my failure to

belong to the PCG. "I brought a nice offering to give," I said in a last attempt to persuade him.

Christianity's traditions on sex lead to lies, shame, confusion

the end result as *very good* (Genesis 1:31)

Adam, Eve and David

We read in Genesis that Adam and Eve "were both naked, the man and his wife, and were not ashamed" (Genesis 2:25).

You remember the story. It was Adam and Eve who decided that their bodies were shameful and they should hide them (3:7-11).

God did not create Adam and Eve to perceive an innate shame about their bodies. This was something they acquired after they were created (with a little help from the serpent-devil).

We read that many years later David danced before the Lord without inhibition or self-consciousness (2 Samuel 6:14).

David's wife decided he had behaved shamefully because the priestly garment he was wearing had unnecessarily exposed him to some girls in the crowd (verses 16-20).

David, however, scolded her for her attitude and implied that God and the girls who had witnessed his dance would not consider his performance to be shameful (verses 21-22).

Brethren, we are the ones who have attached shame and sinfulness to our bodies, *not God!*

God is the author of attraction

God designed our bodies. He instilled a sexual appetite in humans. He designed us to be physically and emotionally attracted to each other.

When you think about it, does it make sense for God to give us sexual desire and then forbid us ever to satisfy it?

Deep down, we understand these truths, but many of us continue to insist that nudity (as with David's dance) and sexual attraction are tainted with sin and shame

Maybe we need to reread the Song of Solomon. For many of us sexual attraction is just another word for lust, and everyone knows lust is bad.

Christ did say that "whosoever looketh on a woman to lust after her hath committed adultery with her already in his heart" (Matthew 5:28).

There you have it. Any time a man looks at a woman with lust in his heart, he is guilty of adultery.

Or is he? And what about a woman lusting after a man? What was Jesus talking about in this passage?

Confusing attraction with infidelity

Is it possible that this scripture has been taken out of context and its meaning twisted?

Notice what Christ said just prior to the verse about looking on a woman: "Ye have heard that it was said by them of old time, 'Thou shalt not commit adultery' " (verse 27).

On closer examination, it becomes

On closer examination, it becomes clear that Christ was speaking about the commandment concerning infidelity.

In other words, after one is committed or married to another person, it is indeed wrong to indulge in sexual fantasy about anyone else. (The original Greek word implies something much more serious than finding someone attractive.)

Hence, the original commandment and Christ's elaboration of it specifically address sexual activity (or the imagination of sexual activity) with others after entering into a committed relationship with another person.

Sexual attraction between single adults is a normal and healthy feature of how Almighty God designed us to work. Married folks, however, are expected to direct all of this natural energy and attention exclusively on each other.

No specific prohibition

What about sex before marriage? Surely God intended for intercourse to be confined to the institution of marriage.

It will probably surprise many people to learn there is no specific prohibition against premarital sexual intercourse in Scripture.

John Sash wrote an excellent article dealing with this very subject that was published by this newspaper in the

summer of 2010 (see "We've Misunderstood the Bible on Sex," *THE JOURNAL*, issue No. 140, dated July 31, 2010).

In that essay Mr. Sash pointed out that the English word *fornication* does not fit the Greek words used in the original writing of the New Testament.

A contract does not preapply

Still, many will argue that the commandment against adultery is violated by participating in sex prior to marriage.

But a little logic quickly defeats such an argument. When two parties enter into a contract or covenant (like marriage), both parties generally understand that the covenant does not apply to what happened prior to its consummation (unless there is what is called a "grandfather clause").

In short, the contract or covenant is generally understood to govern the behavior of both parties going forward.

Even so, some will point to the fact that a woman who misrepresented her virginity to her husband was to be stoned to death under the Law (Deuteronomy 22:20-21).

Mr. Sash points out that the woman is not stoned for having premarital sex but for misrepresenting her former behavior to her husband.

Again, however, we are forced to ask: What about a man who has misrepresented *his* behavior prior to marriage? Does this principle apply equal-

dition is not on the same par with whatever God's will happens to be on this or any other subject

this or any other subject.

What about marriage? Where did it originate? Is marriage God-ordained or the product of human tradition?

No marriage ceremony in the Bible

In beginning to answer these questions, we should note there is no prescription for a marriage ceremony anywhere in the Bible.

Does that shock you? Let me repeat: There are no ceremonial prescriptions regarding marriage in the Bible.

"But I've heard the words recited at Christian marriage ceremonies all of my life," some will protest.

Even so, I challenge you to find such a ceremony in the Bible. You will not find one. Our marriage ceremonies are based on the traditions of men. Granted, much of the wording and

symbolism in these ceremonies is based on scriptural teachings, yet the fact remains that God did not give us a formula for a ceremony. Even when we go all the way back

Even when we go all the way back to the beginning of the Bible we cannot find any evidence of any kind of formal marriage ceremony for the first man and woman.

We simply read that the man and his wife were naked and that they were not ashamed of their nakedness (Genesis 2:25)

If I'm right in this line of reasoning, Paul had no

Three parts of a marriage

So what exactly constitutes a marriage in God's eyes? I believe the Bible reveals three components of a Godrecognized marriage:

■ The act of living with another person.

■ The sexual act itself.

■ A commitment to love and devote oneself exclusively to one other person.

The first two principles are summarized thus:

"Therefore shall a man leave his father and his mother, and shall cleave unto his wife: and they shall be one flesh" (Genesis 2:24).

Christ quoted this scripture when he was speaking about divorce, which we will reference again later when we are addressing that subject (Matthew 19:5).

The third principle is explicit in the Seventh Commandment: "Thou shalt not commit adultery" (Exodus 20:14).

Moreover, all three principles are reinforced by Paul's instructions about marriage to the Christians at Ephesus (Ephesians 5:22-33).

Are you sure you're single?

Therefore, in reviewing the biblical components of a marriage that is valid in God's eyes, it quickly becomes apparent to readers that a good many people who formerly regarded them-

You may personally be responsible for answering to God for how your child was conceived, but the child is yours just the same.

Paul instructed fathers to bring their children up "in the nurture and admonition of the Lord" (Ephesians 6:4). God expects fathers and mothers to love, protect and support their children regardless of the circumstances of their conception.

Can a marriage genuinely end?

As part of a discussion about marriage, a few words about divorce are appropriate. What constitutes a legitimate reason (or reasons) in God's eyes for ending a marriage?

In times past, human traditions in this regard have often contradicted or been at odds with God's original intent. Moses told the Israelites:

"When a man hath taken a wife, and married her, and it come to pass that she find no favor in his eyes, because he hath found some uncleanness [disgrace, blemish, shamefulness] in her: then let him write her a bill of divorcement, and give it in her hand, and send her out of his house" (Deuteronomy 24:1).

Nevertheless, Christ refuted this teaching during His own ministry:

"It hath been said, 'Whosoever shall put away his wife, let him give her a writing of divorcement': but I say unto you, That whosoever shall put away his wife, saving for the cause of fornication [the Greek word implies chronic, habitual infidelity or sexual misconduct], causeth her to commit adultery: and whosoever shall marry her that is divorced committeth adultery" (Matthew 5:31-32).

Putting asunder not allowed

Later the Pharisees asked Jesus about this teaching:

"Is it lawful for a man to put away his wife for every [any] cause?" (Matthew 19:3).

Notice Christ's reply: "Have ye not read, that he which made them at the beginning made them male and female, and said, 'For this cause shall a man leave father and mother, and shall cleave unto his wife: and they twain shall be one flesh?" Wherefore they are no more twain, but one flesh.

"What therefore God hath joined together, let not man put asunder" (verses 4-6).

Jesus explained that marriage makes a husband and his wife *one* in God's sight and that man does not have the ability to make them *two* again.

This also refers to the original creation of humankind when God bequeathed to the male and female different aspects of the divine character (Genesis 1:27).

What makes a child illegitimate? Before we leave this topic we'll Divorce only because of infidelity

Before we leave this topic we'll consider the question of children born outside of the sanctity of marriage.

Most "Christian" societies have historically regarded children who are born outside of marriage as in some way inferior to those who are born within the confines of that institution. They have attached names like baseborn, bastard and illegitimate to such children.

Once again we have to ask ourselves: How does God regard these children?

To answer, we must look at God's basic principle regarding personal responsibility. This standard is often overlooked by church leaders and their members.

In Ezekiel we read: "The soul that sinneth, it shall die. The son shall not bear the iniquity of the father, neither shall the father bear the iniquity of the son: the righteousness of the righteous shall be upon him, and the wickedness of the wicked shall be upon him" (Ezekiel 18:20).

No child left illegitimate

The principle is clear: God holds each individual responsible for what he or she has done.

Hence, the practice of placing the onus on these children for something their parents did or did not do is not biblically sound.

Any child a father and mother

Even so, the Pharisees persisted in holding onto the tradition established by Moses:

"They say unto him, Why did Moses then command to give a writing of divorcement, and to put her away? He saith unto them, Moses because of the hardness of your hearts suffered you to put away your wives: but from the beginning it was not so.

"And I say unto you, Whosoever shall put away his wife, except it be for fornication [infidelity], and shall marry another, committeth adultery: and whoso marrieth her which is put away doth commit adultery" (Matthew 19:7-9).

Therefore we could legitimately say Christ explicitly defines God's criteria for ending a marriage.

Paul had no authority to change Jesus' marriage instructions

What about Paul's instructions on marriage, divorce and remarriage? (1 Corinthians 7).

Again, context is important. Sometimes we forget Paul was writing letters to specific churches, often addressing circumstances that were specific to a specific audience.

ly to men? And, if not, why not?

This is just one example among many where the language relative to sex seems to be prejudiced in favor of the man.

Culture and times

Context is important, brethren. We cannot begin to understand or interpret these scriptures without an understanding of the culture and times in which they were written.

In ancient times most cultures were male-dominated (and the Israelites were no exception).

Further, most of these cultures (including the Israelites') were overtly misogynistic in the application of their laws as well as the roles they assigned to women.

In other words, many of the laws and regulations pertaining to male and female rights and roles were cultural. They should not be regarded as universally applicable, eternal spiritual principles.

Marriage virtually universal

Similarly, note that most cultures and societies developed traditions relative to some kind of marriage ceremony between their males and females.

As we study world history, we find the phenomenon to be almost universal.

Hence, it is reasonable to be curious about the origins of marriage traditions and how they developed down through the millennia of human existence on this planet

Even so, we must acknowledge and underscore the *fact* that much of our understanding of marriage is based on human tradition.

Tradition can render God's Word less effective

We know that Christ scolded the scribes and Pharisees about "teaching for doctrines the commandments of men" (Mark 7:7).

"For laying aside the commandment of God, ye hold the tradition of men" (verse 8).

He concluded by informing them that they were "making the word of God of none effect" through their tradition (verse 13).

No biblical marriage ceremony

Traditions can be good or bad. Some are harmonious with the revelation of Scripture.

Nevertheless, we as Christians must understand and acknowledge that tra-

Later we learn that Adam "knew" (had sexual relations with) his wife and that she became pregnant and gave birth to a son (Genesis 4:1).

Marriage notions developed

In terms of the Bible, our discussion about marriage traditions must focus on the Israelites. It is, after all, their story we read throughout most of the Old and New Testaments.

Nevertheless, a word of caution is in order in reviewing the traditions of the Israelites: Not all of their customs with regard to marriage were in sync with God's expectations regarding that insti-

tution (e.g., the practice of polygamy).

Keeping in mind the pertinent scriptures, we should note that it appears that a festival or celebration was central to the marriage ceremony (Genesis

29:22; Judges 14:10).

This celebration, or party, was immediately followed by the consummation of the marriage by the bride and groom (Genesis 29:23).

Moreover, marriages were usually arranged by the parents or guardians of the bride and groom (Genesis 24, 29).

The festival, not the 'I do' vows

We read that the marriage of Ruth and Boaz was heavily influenced by Israelite inheritance customs (Ruth 4).

Nevertheless, although the tradition of the marriage festival appears to harmonize with our notions of a wedding reception, it is evident that the *festival itself*—not a reciting of vows—was regarded as the marriage ceremony by

the Israelites.

This conclusion is reinforced by the traditions in place in Christ's day. For example, His first miracle was performed at a marriage festival in Cana of Galilee (John 2:1-11).

It is further reinforced by the portrayal of Christ's marriage to His

"Let us be glad and rejoice, and give honor to him: for the marriage of the Lamb is come, and his wife hath made herself ready. And to her was granted that she should be arrayed in fine linen, clean and *white* [another tradition that carries over into modern Christian wedding ceremonies].

"For the fine linen is [symbolizes] the righteousness of saints. And he saith unto me, Write, Blessed are they which are called unto the *marriage supper* of the Lamb. And he saith unto me, These are the true sayings of God" (Revelation 19:7-9).

Leavened Bread Cannot Picture Firstfruits

eavened bread pictures something unholy and sinful, and so the leavened loaves "are unlikely to picture the Firstfruits." So says Ozwitness in an article in The Journal, issue No. 154, "An Abib Resurrection?"

This statement has been stated and restated by many for as long as I can remember. The basis for this reasoning is that leaven represents sin; therefore offering loaves with leaven in them is offering sin—or, as Ozwitness says, pictures "something unholy and sinful."

Notice Ozwitness doesn't quote any scripture to prove his point? One important point that he and others miss "Does God allow anything that represents sin or is sinful to be offered?" Wouldn't offering two loaves of sinful leaven be the same as offering a pig or something else unclean? Is not the idea clearly preposterous? Ozwitness uses Revelation

14:5, "And in their mouth was found no guile for they are without fault before the throne of God," as proof of his point of view. Ozwitness, is it possible that "guileinsidious, treacherous, cunning, deceit" is to be found in your statements?

When considering the meaning of the two leavened loaves that are offered,

shouldn't the most important. relative scriptures have been taken into consideration?

Matthew 13:33: "The Kingdom of Heaven is like leaven, which a woman took and hid in three measures of meal till it was all leavened." And Luke 13:20-21: "And again He said. 'To what shall I liken the Kingdom of God? It is like leaven which a woman took and hid in three measures of meal till it was all leavened."

fies as being an acceptable offering in the case of the leavened loaves, which Ozwitness implies, seems unbelievable to me. Another point: When leav-

en is put into dough and it is baked, then the leaven becomes inert. It can't be used to leaven anything any more than unleavened bread can be used to leaven.

That is why people drink wine and beer during the

Leaven is neither good nor bad, sin nor righteousness, God's Holy Spirit nor Satan's spirit.

Leaven is not like a pig. It is not sin, unclean or evil or, as Ozwitness states, "some-thing unholy and sinful." It is neutral. It can be used as a type, such as sin or God's

Holy Spirit, to make a point. Is it beyond consideration that, in the case of the two leavened loaves that are offered, they are absolutely not unclean, unholy or representing sin in any way, and are in fact fully accepted to be offered as a Godly offering?

Is not this leaven a type of God's Holy Spirit, as described in Matthew 13:33 and Luke 13:20-21?

The idea that God lowered His standard of what quali-

Days of Unleavened Bread; the leavening that was used to make the beer can no longer be used to leaven anything. Therefore, wine and beer can be drunk during the Feast of Unleavened Bread.

Again, leavening is neither good nor bad, is neither sin nor righteousness, is neither God's Holy Spirit nor Satan's spirit. It can be and is used in many ways: to bake a cake or draw an analogy from, like we do with many things such as snakes, serpents, dogs,

pigs, fire, water, etc. The two loaves meet the strict requirements that God demands for an acceptable offering. There was nothing

unholy about them, from their preparation to the end of their being offered. They were never unholy and then got cleaned up or had a facelift. The problem is with human ideas about them.

Why do I suspect that Satan would love us to believe that God will lower His standard as to what an acceptable offering is, like offering sinful loaves? It's because Satan loves to quote but misapply God's Word. Ozwitness states,

"Leavened Bread Cannot Picture Firstfruits"; then quotes God, "You shall bring from your dwellings two wave loaves of two-tenths of an ephah. They shall be of fine flour; they shall be baked with leaven. *They are the* firstfruits to the Lord.'

Ozwitness apparently expects us to believe his statement, "However, those loaves contain leaven, and so are unlikely to picture the firstfruits who become Christ's Bride, who are counted as holy and sinless by Christ." The question is, does his opinion override God's plain statement of fact?

The last person I question concerning this belief knighted me with the "Servant of Satan" title. I expect a similar honor will come from Ozwitness.

I Corinthians 7:15 does not allow divorce

God believe I Corinthians 7:15 does allow divorce. Let's look at a translation that reflects the original Greek without ambiguity. "And, if the unbelieving doth separate himself—let him separate himself: the brother or the sister is not under servitude in such cases, and in peace hath God called us" (Young's Literal Translation).

Although the English is somewhat archaic, Young's translation reflects the unambiguous meaning of the Greek douloo, which primarily means 'become a slave.' I Corinthians 7:15 is not saying anything about a marriage being unbound, but that the believer is not enslaved by the unbeliever. How could the believer be enslaved?

Jesus taught, "Therefore what God has joined together, let not man separate" (Mat 19:6b). Paul paraphrased this in I Corinthians 7:10c. "A wife is not to depart from her husband." If the believer were absolutely required to 'not separate' from the unbeliever, wouldn't the believer be at the mercy of the unbeliever? The unbeliever could simply threaten to leave and the believer would be forced to do the will of the

believer would be little better than a slave to the unbeliever.

Paul made his judgment here based on the overriding need to make peace. Jesus' instruction was to Jews. Jesus did not address a situation where a mate was an unbeliever from a different culture. Paul understood that the believer was not absolutely required to live with the unbeliever, even though Jesus' statement taken literally would indicate otherwise.

Paul's statement is also an example of typical Hebrew parallelism. This is the proclivity of Hebrew speakers to be somewhat redundant. "A brother or a sister is not under bondage in such cases" is just another way of restating and reinforcing his instruction: "But if the unbeliever departs, let him depart." The believer is not his/her mate's slave.

Doesn't a separation imply a divorce? This doesn't follow. The very next verse Paul exhorts those involved to keep in mind that their conduct could still win over their husband or wife. "For how do you know, O wife, whether you will save your husband? Or how do you know, O husband, whether you will save your wife?" If they were diband or wife and would have little or no influence on the unbeliever.

In I Corinthians 7, Paul is not talking of divorce at all. The NKJV uses the word in verses 11-13. In fact a meaning of 'divorce' for the Greek aphiemi is very questionable. The three or four good lexicons that point to examples of ancient usage supposedly intending 'divorce' all point to Herodotus 5:39 to justify this meaning. That passage does talk of a monarch sending away his wife and marrying another, but it doesn't use aphiemi at all. It would not have been a typical divorce in any case. Former queens were not typically allowed to remarry (I Kings 2:13-25).

The primary meaning of *aphiemi* is 'send away.' Depending on circumstances it can also mean 'leave.' Paul is making judgments based on the teaching of Messiah. Paul knew Jesus' instruction was based on "the two shall become one flesh" (Mat 19:5c) and "Therefore what God has joined together, let not man separate" (Mat 19:6b).

If one uses the primary meaning of aphiemi, there is no conflict with Messiah's instruction. Paul knew "A wife is bound by law as long as her husband lives"

any within the churches of unbeliever to avoid separation. The vorced, they would no longer be hus- (I Cor 7:39a). This doesn't mean they must live together.

In I Corinthians 7:15 Paul is not allowing us to divorce, but explaining how to live in peace and still honor our commitments. God is faithful. He expects us to be faithful too. "For how do you know, O wife, whether you will save your husband? Or how do you know, O husband, whether you will save your wife?" (I Cor 7:16). If the unbeliever totally severs the relationship, that is on him/her. 'His disciples said to Him, "If such is the case of the man with his wife, it is better not to marry." But He said to them, "All cannot accept this saying, but only those to whom it has been given" (Mat 19:10-11).

Are you serious about honoring your Creator and understanding His mind? This is simply one chunk of the iceberg of misunderstanding that blinds (Rev 3:17) the churches of God. Don't assume this is the only thing that is misunderstood about the marriage relationship. Don't wait for someone ordained of men to look into this for you. Develop your own relationship with the real head of the congregation of God by an in-depth study of His word.



than 500 young people (age 12-25) sitting in the audience from around the

She continued:

I want education for the sons and daughters of the Taliban and all the terrorists and extremists. I do not even hate the Talib who shot me.

She also said:

"The extremists were, and are, afraid of books and pens. The power of education frightens them. They are afraid of women. The power of the voice of women frightens them."

She summed up:

It goes without saying that I am an unabashed, completely convinced Christian, a follower of Jesus the Christ.

It is also true that I have a real problem with the road down which Islam is taking the world.

(Lest you take that as a slam against Islam, understand that I have exactly the same concerns about Western civilization too.)

Jesus' parable

But Malala has caused me to think more deeply about Jesus' famous parable about the Good

If Jesus were speaking the parable to today's followers, the hero of the story would not be a Samaritan—because nowadays it's a compliment to be considered a "Samaritan."

In Jesus' day the Samaritans were an outcast people, at least in the eyes of the Jews. They were considered usurpers, a mongrelized people and troublemakers.

It was upon a Samaritan town that the disciples wanted to call down fire from heaven (Luke 9:54).

Yet Jesus seemed to have a special regard for these people. He used a Samaritan as a prototype of a good neighbor, and it was a Samaritan woman to whom He revealed Himself as the Messiah (John 4).

So, while there might have been a goodly share of Simon Magus types running around Samaria (Acts 8:9-23), it was one of the first places outside of Judea to hear the gospel, and the people accepted it.

What would Jesus tell?

Malala has caused me to wonder: If Jesus were telling the story today, would it be instead the Parable of the Good Muslim? I kind of think so.

Forget the Calendar... Let's Talk About God's Feasts

ne of Satan's most effective tools in misleading the churches of God is to get the church off track, and heading in the wrong direction. In the earliest days of the New Testament Church, as reported in the pages of your Bible, we see that there were some within the Church of God who attempted to force the Gentiles to go through Judaism in order to be a good Christian (Gal 2:11-14).

Satan's methods and goals seldom change: Get the church off track and headed in the wrong direction.

Since the mid-1990s the Church of God has been misdirected into a continued discussion about the calendar issue. As Christians who are concerned about the proper keeping of God's annual Feasts, the subject has drawn widespread attention.

One Church of God teacher informed me that he had written over 1,000 pages on the subject of the calendar. One could say that that may be a bit of overkill. There are, however, a few key points that we must understand before we are able to have a discussion of any substance.

Are you aware that:

- God never gave Israel a calendar?
- He gave them Feast days?
- The word *calendar* never appears in Scripture?
- Calendar is never mentioned in the seven major English translations of the Bible?

Furthermore, although most of the mainline churches of God claim to follow the Hebrew calendar, there is never a mention of the Hebrew calendar anywhere in the Scriptures. How in the world can they claim to follow something does not scripturally exist? If they were honest about what they are doing, they would admit that they are simply following a Jewish tradition without scriptural backing of any kind.

Please don't take any of this as a condemnation of the Elders of God's church. They are merely following a tradition that was placed into the

church by HWA and Dr. Hoeh. Both of these gentlemen were men of good spirit and well intentioned.

This reminds me of Mark 7:7-9: "Howbeit in vain do they worship me, teaching for doctrines the commandments of men. For laying aside the commandment of God, ye hold the tradition of men . . . Full well ye reject the commandment of God, that ye may keep your own tradition."

Question? If we can become sloppy with the keeping of the Feasts, what's next?

The Sabbath? Tithing? Clean and unclean? Look what happened when the church of God at Rome decided to move the "keeping of the Paschal celebration" from the 14th of the 1st month to the Sunday after the full moon (Cat. Ency. article "Easter").

chodesh. The translation of that am profaned among them." Hebrew word is "New Moon."

In 1611 A.D., when the King James scholars translated the Scriptures into English, it was natural for them to use the word *month*, because by 1611 they were not recognizing the new moon. If every time you read the word month in scripture you said the words "new moon," you would eventually realize the significance of what the translators did in honest error.

When we realize that every Feast of God is directly connected to a new moon, we will see more clearly the evidence of the simplicity with which God created His Feasts.

When the nation of Judah was in captivity, the Word of God inspired the Prophet Ezekiel to condemn the spiritu-

In verse 30 he said he looks for a man to make a hedge and stand in the gap before him, and he found none. How sad it would be if that Scripture came to pass.

The question we might want to address is this: How difficult is it to calculate the annual Feast days, as God gave them to Israel?

If you have a fifth-grader in your group or in your family circle, put a calendar in front of them and asked them to count from day 1 to day 15. Then ask them to count 7 more. Congratulations! They just accurately enumerated the seven days of Unleavened Bread.

Now, from the weekly Sabbath within the Days of Unleavened Bread, ask them to competent, understanding, converted human being to tell us when the first day of the seventh month occurs.

The Jewish leaders can give us numerous reasons why they choose to make the calculations so difficult and so convoluted. These numerical gymnastics were never a part of God's will or His Word.

Brethren, God did not give a group of Ph.D.s the understanding of his annual Feasts? He gave them to a group of wandering Hebrews living in the desert with no scientific instruments of any kind.

Why is the church leadership unable to get together and tell us when and how to do it properly? Most of the church leaders that I know personally are converted, honorable, educated, dedicated men of God. I don't think it would be disrespectful to ask them the question: Why do you refuse to get this issue out in the open instead of hiding behind one obscure text about "the oracles of God"?

In my opinion, God's people are not going to sit idly by while some of the major questions about God's Feast days go unanswered.

The Church of God in my opinion needs to be reconciled not only with God but with one another. Instead of reconciliation, we see split after split with no end in sight. Is there anyone who earnestly believes that God is pleased with the splits that have occurred and continue to occur within His body?



— Just Table Talk — Is God Omnipotent?

Q: How Do Ignorance and **Universal Evil Affect the Reality** of God's Power?

Part Two

bout This Series: The written segmented apparatus of "Just Table" *Talk*" being offered within the pages of *The Journal* is ideally meant to represent a simple inclusive idea: a friendly discussion of various thoughts and views that a family might have at the kitchen table concerning the attributes of God, and other stuff.

Rather than lecture or browbeat folks about possible irregularities within Christian thought

and practice, or within the Bible (which I have done already more than once), I prefer to communicate on a more informal, personal and expansive or reasoning level. Perhaps you will be persuaded to act. That would be gratifying. But forgive me if I stray off point or actually attempt to browbeat and lecture you a bit; I was a technical instructor for quite a while, and such teaching methodology runs in my blood. **About Truth:** Alas! I find myself on

self-imposed perilous mission. My goal: challenge and perhaps eventually persuade a few hardy souls to think outside of the box in order to discover bits and pieces of the truth on their own.

I have discovered that Truth is like water. Try to contain and stifle it and somehow, sooner or later, no one knows how, it finds its way out of its dingy, poorly lit prison.

In its dungeon, Truth drips, dripping, dripping, inexorably like a leaky faucet in the night, quietly at first, then louder and louder, shouting to its guards. Even in our lifetimes, we have witnessed this phenomenon time and again.

Truth cannot be long contained; it always escapes. Look to the governments and the subjugated peoples around the world and their cries for liberation for corroboration. In spite of keepers' vain attempts to prevent its escape, Truth breaks down locked doors. Truth flees. Truth breaks out shouting, "Free at last! Free at Last!!...Listen to me!!!"

At long last, to the chagrin of said ironfisted keepers and wardens, restless minds awaken, take notice of the leakage and rescue Truth for

Like downy feathers in a high wind, Truth, once set free, can never be returned to its prison. Again, like water, Truth slips through tightly balled fists and relentlessly spreads its way into open minds. And the world can never be the same again.

Obstacles to Communication: In any challenging project, such as this, communication is essential. No communication, no comprehension. No comprehension, no tolerance. When authentic communication ceases, any open-mindedness one may have had for the other's view suffers.

Open-mindedness does not presume compromising one's principles; it merely presumes one's willingness to understand, learn and perhaps grow closer to Truth, And, to the intellectually honest person, all this may wind up being at the expense of one's adopted belief system.

One who is open-minded does not automatically waver in his belief system, or fiddle with his principles, but is simply receptive to considering, as much as possible without prejudice or bigotry, new ideas, thoughts or opposing views.

A closed mind, of course, is not receptive to new or different ideas without injecting prejudice or bigotry into the exercise. Like a blocked artery, a closed mind goes nowhere and does nothing.

In virtually any religious quarter, communication can easily and quickly become strained due to misunderstandings. By not choosing our words carefully, we readily confuse and confound listeners or readers, some of whom may

not be accustomed to the demanding burden of attentive listening. Admittedly, I have been quilty of such poor word choices and pitiable listening behavior.

We would do well to pay attention to how we convey our thoughts—and thereby avoid unintended consequences of our verbal communication habits. Ambiguity and vagueness are fairly common within much religious thought, by choice or by chance.

One way to rid ourselves of the plaque of vagueness, ambiguity, and the miscommunication squabbles that follow, is to choose our words with care. Additionally, we would do well to have our selected terms supported by proper and accurate definitions. Indeed, these points are

two of the most useful methods of facilitating comprehensible communication.

Intellectual lethargy often gets in the way of our choosing appropriate words meant to express our thoughts.' Oddly enough, otherwise knowledgeable and bright people frequently limit their vocabularies to the sound bite" or thoughtless gut reaction based

upon previously adopted ideas.

Religious folks will limit themselves similarly, even to the point of echoing shallow doctrinal positions they may have embraced, splashing them liberally about, thinking that in their care-less speech they have said something weighty.

Even professional journalistic-type talk-show anchors are guilty of rank amateurish speech. Sunday-morning preachers are not excluded from this observation. Mean what you say and say what you mean is still a good axiom.

Knowledge is the great enemy of blindness, partial and absolute, physical or spiritual. Knowledge facilitates communication. Knowledge fights against superstition and irrationality and wins every battle. Knowledge has the ability to free all of us from the blinders we cause, in my mind, the subject has not yet been satisfactorily concluded. Indeed, much of mankind, religious or otherwise, has struggled with this topic for centuries without a satisfactory conclusion. Depending on one's disposition, there may be no satisfactory conclusion at all!

On the other hand, some religious folks do not struggle with this topic; they know. Many would readily affirm that God is not only omnipotent, but would include in their assess-

ment other corresponding "omni-'s" as well. And this sincere belief may come about because uninformed, ignorant or lethargic preachers within many Christian communities teach God's absolute omnipotence, omniscience, omnipresence and omnibenevolence. These four traits are universally associated with God. And religious persons, by and large, simply accept them all at face value because they are traditionally assumed to be true.

Who, and What, Is God? With a few exceptions, the four "omni" characteristics of God are said to be "implied" within the Bible some say they are clearly confirmed therein. Others deny this. Nonetheless, one must be wary of inférence or assumptions based upon church practices, creeds, biased interpretations and doctrinal sensitivity.

I therefore warily propose that lack of spiritual discernment and closed minds have a great amount to do with the concept of God's power and influence

Further, I put forward that the Christian world in large part has strayed far from the truth of the matter, inasmuch as it can be discerned. Mistakes, confusion and lethargy in this area can greatly modify one's perception of reality.

It has been said that the authenticity of God's omnipotence, his total power to do virtually anything, has been greatly exaggerated. Could that be accurate? Would average religious people or even the biblical authors really exaggerate God's attributes or amplify his traits?

It has already happened. Is everything real-"possible for him who believes" (Mk. 9:23)? In the Psalms we find much source material for implications about the traits of God. For instance, in Psa. 147:5 the psalmist in his song claims that there is no limit to God's understanding; i.e., God knows all things.

Ignorance and the Problem of Evil: Perceptions of God's omnipotence, his great unlimited power over creation and his goodness are affected by several key issues besides the ones already noted in the last issue. Two are prominent.

The primary issue is called the *Problem of* Evil. Evil is not limited to dreadful events: violations of civil and moral law run the gamut from disobedience to the rules of the road to gross wickedness

At every level, the world is steeped in evil. Considering such massive evil as the norm, it is out of God's control. And, if this is true, it has always been out of God's control.

I am perplexed. Why is it that all forms of evil, depravity and general misconduct are so widespread, common and, seemingly, increasing? Within the pages of the Bible, God is assumed to be in control of evil. Outside of the Bible, God's control and influence over evil has vanished. What happened?

"By design," some say; God adopted a "hands off" attitude; he is deliberately holding back, waiting for us to finish the gun lap.

But I wonder. Is *that* in the Bible? And when exactly did he adopt that attitude? Why handson *in* the Bible but hands-off *outside* it?

A less prominent issue respecting God's assumed omnipotence is devotee ignorance. Ignorance is unawareness or lack of knowledge.

Intellectual impoverishment does not necessarily equate with immorality; ignorance does not make one a bad person. Likewise, goodness is not limited to the learned and sophisticated among us.

On the other hand, willingly ignorant persons twist inward, turning a deaf ear to societal and religious development, stunting their own ntellectual maturity. Lack of knowledge seems to have a profound effect upon the celebrated manifestation of God's unconditional power and influence. Ignorance often results in blind faith. Been there, done that.

Sickness has been said to be a trial of faith. For instance, some have taught that medicines are not needed by the faithful: *only have faith* in God to heal.

Blind or unsupported faith can be a trap for the unwary. Remember Jonestown. Certainly, countless Christians are very bright and knowledgeable in any number of fields, but the bulk of Christendom seems to be happy grasping only popular religious clichés and trusting preachers to tell them the truth.

As a result, ignorant people are often snared into adopting a false god or gods, or invented gods. But three gods, two gods, many gods, growing family gods, no gods—are all the same: artful delusions.

The unintended consequence in adopting such illusory artificial gods is that such artificiality and misplaced trust negate many levels of truth. How can one know or experience the true God by supporting false gods?

There is much energy expended and authority employed in the defense of multiple-god religious convictions. I have heard and understand the arguments. But truth is truth even if it is embarrassing or challenging. Truth is truth even if it is not balanced, is not in harmony with adopted doctrine, is not agreeable, or just makes one feel bad.

Here's the point: *Ignorance breeds misunder*standing, false confidence, false trust and false expectations. It breeds apathy, indifference, distrust of "strangers" and much fear of ideas from "outside." At the end of the day, ignorance may lead to entombment in false belief.

Ignorance is not bliss. Those who are ignorant have limited abilities to withstand all sorts. of evil, and they are routinely taken advantage of by the clever ones in our midst, even from

wear. Bible believers are duty bound to "grow in grace and knowledge.

(Here, it is presumed that along with knowledge comes a certain amount of responsibility and, eventually, wisdom.)

How many opportunities have we missed in our lifetimes? Opportunity to remove blinders comes toward you so very slowly that you cannot help seeing it, if you will see it. It cree like a snail, passes you, seems to make up its mind that you are not the person to seize opportunity, and it is gone in a second. Others let opportunity go by, too much startled when they see it, or they are too bewildered or intimidated to recognize it and to firmly take hold of it.

In Retrospect: One might wonder why I am harping upon topics that, at first glance, do not seem to deal with the main issue I am addressing; i.e., the omnipotence of God and how evil affects that reality. To respond, I submit that numerous side issues bear upon God's real or imagined omnipotence, as will be shown, while the main thrust relative to the issue above becomes who or what God is said to be.

The words "real or imagined" are used be-

The psalmist also claims in 147:6 that God throws the wicked to the ground, and, in 18:8, smoke came from God's nose and fire from his mouth. Could these be examples of poetic li-

cense, hyperbole or just plain hero worship?
I am unaware of God throwing anyone to the ground. Sincere adulation of an individual is common in the ignorance of heroic and anthropomorphic superhuman tradition. Can you think of any heroes today who are "bigger than life"—heroes who are virtually mythologized?

Logically, it is assumed, an eternal Creator God has to be omnipotent—a super-being. What else could he be? After all, how could a weak God (or Gods) have created the Universe?

My point: Trinitarian Caleb Colley, M.L.A., writes: "God has complete power over the earth . . . over the spiritual realm . . . over the affairs of men . . . over the devil. . . . God's complete power is unending. [Why? I ask.] Because God would not be God if He were not omnipotent . . ." (www.apologeticspress.org).

the pulpits. Ignorance might not seem to be significant relative to God's omnipotence, at first glance. But make no mistake. Those with limited knowledge have limited competence. And they can wind up unknowingly becoming lockstep-followers.

Therein we find the danger. Much of what the truly ignorant know or think they know has been spoon-fed to them by trusted leaders. In effect, many believers practice blind acceptance of the preached word.

Trust but Verify. Historically, millions of trusting believers who have not verified have been victims of their adopted belief systems.

Since there is arguably "nothing new" under the sun, any given belief system may have roots traced back to earlier concepts. For instance, the Triune god of mainline Christianity has parallels in mythology and paganism; early peoples (and Constantine) worshiped the Sun (Sol Invictus, the unconquered sun), depicting this god with rays around his head, similar to the "halos" of Christian imagery.

Some persons have suggested that simply because a number of individuals living during the early centuries of the "common era" practiced various forms of multiple-god worship (as in binitarianism or trinitarianism), this fact confers legitimacy to those two forms of polytheism, especially to binitarianism. the two-god-plus model.

cially to binitarianism, the two-god-plus model.
But placing one's spiritual life and future in
the hands of an inferred, unreliable legitimacy
is a dreadful miscalculation.

Evil and ignorance cut across all boundaries; no border, no gender, no race is safe from the plague of evil or the blight of ignorance. Enemies abound.

Corrupt and evil despots have ruled lesser worlds virtually unchecked since humanity has begun; many of these zealously followed one religion or another.

Corruption in places of authority has *never* abated—it continues virtually unchecked. Witness millions of innocent victims destroyed by notorious tyrants.

Paranoia has nothing to do with it; we are surrounded by dangerous creatures, whether two-legged human monsters, thugs, small-minded authoritarians or multi-limbed "lower" life forms that want to cause us harm.

Many unscrupulous and unprincipled individuals populate the world, even within religious communities, that operate inconspicuously but with grave effect, taking advantage of the weak and ignorant. But that's not news.

One argument for atheism is that the presence of monstrous evil negates a good God and is consonant only with a malevolent God or none at all. According to atheist reasoning (www.infidels. org), the argument from evil (the problem of evil) is that an all-powerful, all-knowing and perfectly good God would not allow any—or certain kinds of—evil or suffering to occur.

The evidential (or probabilistic) argument from evil contends that some known fact about evil is evidence against the existence of God. Other versions of the evidential argument concede that God could have a morally sufficient reason for allowing certain evils to occur—e.g., to ensure that some greater good is achieved as a consequence of an evil.

However, proponents add, *God would allow* only as much evil or suffering as is absolutely necessary in order to achieve greater good.

But, when we look at the world around us, we find prevalent instances of apparently *gratuitous evil*—pointless evil from which no greater good ensues. According to proponents, the existence of apparently gratuitous evil provides strong evidence that God (as traditionally defined) does not exist (William Rowe, *Philosophy of Religion*).

The atheist reasoning above is persuasive, and some points seem unanswerable. Even the supposed Hell-Fire of Christendom where God burns sinners *forever* militates against a good God.

Perhaps gratuitous immoral evil is the *only* real type of evil. If an evil occurs that begets a "greater good"; e.g., one soldier dies to save many others; can the one death be deemed good or bad, gratuitous or beneficial, or both?

Would it be unwarranted or justified? And, if justified, can it still be deemed evil?

Evidently, degrees of evil exist. At what point on the scale from mild wrongdoing to monstrous wickedness does evil become tolerable to us or to God?—or benign, necessary, even good? Can any evil be insignificant and non-corrupting?

Then, can *natural evils* really be evil, or just serendipitous? Should a good God be able to control horrific *natural* events? In today's world, God does not seem able to do so. (Or is he just unwilling? That question opens up yet another door.)

Some say that we humans are somehow in a position to limit Yahweh's power. We limit God, they write, through unbelief, fear and disobedience, even ignorance—or through *erroneous thinking*, as Pastor Feeny wrote (see Part One).

This can be confusing. Ignorant flawed humans can limit Yahweh's power? Does God depend on us to somehow help him maintain his power? We humans can block God's power through ignorance and stupidity?

On the other hand, they continue, in order for God to have his long-lost power restored, we have to change. We are told to start trusting the one "who makes the impossible possible." Is that all it takes?

But, if God can make the impossible possible,

After all, was not Jesus a demigod?

Many, if not most, Christian church organizations, Christian groups and assemblies have mistakenly elevated Jesus to pure "God" status, more or less equal with the Father, or Yahweh, but, according to the Bible(!), Jesus was only a demigod, a half-god. He was, it is written, half man, half god. That makes him a demigod.

Anyone born of a human mother but sired by a supernatural being cannot be totally one or the other, by definition.

According to the Bible, then, Jesus was a hybrid. Is it possible that those who worship Jesus as one of the gods of heaven have been duped into demigod worship? The thought is intriguing. This includes all believers who conclude that Jesus is, or was, a co-equal god of the one true God, Yahweh.

The Christian's very own holy book proves beyond any coherent argument that Jesus was only a demigod, *assuming* the truthfulness of the biblical scriptures. Could this be yet another Christian connection to Greek/Roman mythology?

OK. Maybe we *do* need more gods. *Clearly, the totality of evil, throughout the entire world, both moral and natural, far outweighs the good.* Wickedness is winning.

Nevertheless, if the good God is actually

Historically, the charge of heresy has typically been accompanied with great personal risk, even to the point of torture and certain death.

Back in the day, any person foolish enough to advance nonconforming premises to the ruling Roman Catholic Church had two choices: run and hide, or stick around and suffer the severe consequences of an unwisely uttered thought.

Witness Galileo (1564-1642). He unwittingly challenged Roman Church dogma by publishing his scientific conclusions regarding the solar center of the universe. He was arrested on charges of heresy, forced to recant at the hands of the Inquisition and made to spend the rest of his life under house arrest. Has much really changed today?

Today, within many religious groups, it is extremely important to maintain "social equilibrium." Such equilibrium is the lifeblood of most groups and is not necessarily a bad thing.

most groups and is not necessarily a bad thing. Yet, a freethinker, daring to contribute a different opinion or another view of established religious doctrinal positions, upsets equilibrium and brings on tension. When this happens, banishment from the congregation, marking and excommunication are the usual punishments for questioning the status quo, however innocent and fitting one's thoughts may be.

Yet, even these punishments can be difficult to handle. In effect, banishing a person from a religious order to "the world" outside is tantamount to assigning the person to solitary confinement and sensory deprivation.

Marking is a way of highlighting one as an unacceptable person: a throwaway from the society where your longtime friends remain, and, by the way, who are not allowed to contact you. You are deprived of friends, the procurement of stroking, and comfort.

Of course, one should ultimately recognize

Of course, one should ultimately recognize the shallowness of religious societal friendships when a contrary opinion is sufficient to turn folks away. Yet contrary opinions are in fact sufficient to turn religious friends away.

Dare you test your friendships? If doctrinal agreement is the basis of friendship, which I suspect is true in many fellowships and church groups, you have no real friends. Been there, done that.

Freethinking and church dogma cannot long survive side by side within the confines of one's brain—something has to give way.

At what point on the scale from mild wrongdoing to monstrous wickedness does evil become tolerable to us or to God?

—or benign, necessary, even good?

how can we humans sap such great power?

The limiting of God's power by man may sound plausible, but it does not pass intellectual muster. How do belief, courage and obedience *increase* God's power to the point that what was impossible has now become possible?

There is much fogginess about the reality of that teaching. It sounds eccentric. Without further support, it clashes with my intellect. I am fairly certain that millions of sincere believers have obeyed and trusted, had courage even to the death, and some willingly, according to Foxe's Book of Martyrs (brief excerpt below)¹ but, to my knowledge, no rescue team materialized. No one pulled fagots from the fire and doused the flames. And no one chased lions from the arena. Were those believers wrong to obey and trust, to, in effect, throw their lives away?

I speculate. An all-mighty God, who holds little or no apparent sway over massive evil, moral and natural, is puzzling. Moral and natural evil permeates his creation in virtually every nook and cranny.

every nook and cranny.

I very much want God to intercede universally and dramatically over evil and immorality.
But is that possible?

Christian thought is that God is omnipresent, he is everywhere, and has great power. I cringe at the thought. Is it true? If so, what is he doing in all these places? Why is God seemingly unable or unwilling to act?

Every second of every day innocent victims, both children and adults, are, by accident or design, being hurt, killed, maimed, robbed, raped, shot, strangled or bludgeoned to death. And their only crime was to be present.

All this evil angers me. These are not minor events; they are major intolerable ordeals. How painful it is for so many. God is everywhere? God's lack of intervention in the face of the horrific blight of such massive and far-reaching, personalized evil is distressing.

Most of us have heard that God's power is unlimited; that he can do virtually anything he wants, and do no harm. After all, he created life and all the rest of it. But is the singular God up to the task of *limiting* or *restricting* evil?

Many say yes. But, from the evidence, it would seem not. Perhaps binitarians and other polytheists have a point; maybe we do need many more gods and deities, even if they are only demigods² with a lower power quotient.

limiting evil, holding it back, he is in a losing battle, or someone is fudging the numbers. Does God need some help?

Of course, this is not to imply that goodness does not exist today, it does. Good people doing good things can be found in every land, struggling against all odds; may they be abundantly blessed and allowed to flourish.

Stamping Your Feet: An assertion is not

proved by stamping your feet, however hard, fast and loud you stamp them. Neither is an assertion proved by fast talk, changing the subject, asking clever questions meant to sidetrack another in response to a question, or obfuscation.

You may confuse me, but that confusion

does not convince me. Shouting the opposition down with empty assertions and bogus allegations meant to belittle the opponent (the pejorative and disparaging term *heretic* comes to mind) might win the day among one's grinning slack-jawed social group, but it does precious little to advance one's legitimacy.

A majority of persons may rule a country

A majority of persons may rule a country, but a majority opinion proves nothing in and of itself, except, perhaps, that the majority rules. (A pure democracy resembles mob rule; America is not a democracy.)

A thousand individuals who stamp their collective feet in support of any given opinion or conclusion on top of one person asserting his opinion will prevent rational discourse, and may well silence the opposition.

But that stamping racket cannot be proof of the correctness of any argument except perhaps those pertaining to clamor and hostility.

Conservative speakers invited to speak at America's liberal universities have experienced such hostile behavior. When a group of people (or some government entity) "stop their ears" in opposition to calm dissenting voices, what results is not a reasoned argument in support of either group's position; the debate often devolves to a dismissal of the dissenter, sometimes followed up by shrill outbursts and mob rule, accompanied with evil intentions against those who would dare propose an nonconformist position (Acts 7:57).

Consequently, the dissenters may quickly be characterized as heretics against orthodoxy. They must be silenced. Orthodoxy must be preserved. Heresy must not be tolerated or allowed to become established.

¹The general persecutions in Germany were principally occasioned by the doctrines and ministry of Martin Luther. Indeed, the pope was so terrified at the success of that courageous reformer that he determined to engage the emperor, Charles V, at any rate, in the scheme to attempt their extirpation.

"[The pope gave money, troops and horses to the emperor] to assist in carrying on hostilities against the Protestants. Thus prompted and supported, the emperor undertook the extirpation of the Protestants, against who indeed he was particularly enraged himself; and, for this purpose, a formidable army was raised in Germany, Spain, and Italy.

"The Protestant princes, in the meantime, formed a powerful confederacy, in order to repel the impending blow. A great army was raised, and the command given to the elector of Saxony, and the landgrave of Hesse. . . .

"At length the armies met, and a desperate engagement ensued, in which the Protestants were defeated, and the elector of Saxony and the landgrave of Hesse both taken prisoners. This fatal blow was succeeded by a horrid persecution, the severities of which were such that exile might be deemed a mild fate and concealment in a dismal wood pass for happiness. In such times a cave is a palace, a rock a bed of down, and wild roots delicacies. Those who were taken experienced the most cruel tortures that infernal imaginations could invent; and by their constancy evinced that a real Christian can surmount every difficulty, and despite every danger acquire a crown of martyrdom." [Please note that Martin Luther was no saint when it came to persecuting Jews. His hatred of them knew no bounds, according to his own writings, especially in *On the Jews and Their Lies. —FPH*]

²A **demigod**, meaning half-god, is originally a Greek mythological figure whose one parent was a god and whose other parent was human. As such, demigods are humangod hybrids. Examples of well-known demigods include Greek hero Heracles (Roman Hercules), the Celtic hero Cuchulain, the Sumerian king Gilgamesh (who supposedly was actually two thirds god). —*Wikipedia*



The Invisibility of the Devil—Due to the devil being invisible, hardly anyone recognizes him as being behind the unsolvable problems inflicting society that are made known daily by the News Media (*Ephesians* 2:2; John 12:31; Revelation 12:9, 12).

Those who do speak of the devil do not grasp his reality and the depth of what he is doing through his powers of deception, for he appears as an angel of light (*II Corinthians* 11:14-15). He uses leaders of mankind to achieve his diabolical and destructive goals.

Are You Quite Sure You know Which God was the Creator and Lord God of the Old Testament?

The all-capitals form "LORD" occurs over 6,500 times in the OT. For example in Exodus 20:2 the LORD God of the OT addressed the nation of Israel from Mt Sinai, saying, "I am the LORD thy God". Incidentally the singular pronoun "I" marks that the OT "LORD God" speaking is one and not two God Persons. In Isaiah 54:5, Jeremiah 3:14 and Jeremiah 31:32 the LORD God declared being married to Israel and being her Husband. This raises the question, Was the NT Jesus the OT LORD God who married the Nation of Israel at Mt Sinai? as was taught by the former Worldwide Church of God (WCG). If your answer to that question is "Yes", then do you accept that the following are inescapable consequences of Jesus being Israel's Husband?

- That as a result of Jesus marrying Israel at Mt Sinai, God the Father would have remained a single unmarried Father,
- That a single unmarried God the Father must have begotten His Son Jesus through His Son's Wife Israel by Mary,
- That a single unmarried God the Father committed both adultery and incest in begetting His Son Jesus!

Surely those consequences cannot be true and therefore we need to re-examine that teaching by the former WCG and our "Yes" reply to that question. When I became aware of this in 1993 it galvanized me into action by searching the Bible many times from Genesis 1:1 to Revelation 22:21 for the answer. To my amazement I found not even a single minister the slightest interested in that question and its inescapable consequences of a "Yes" reply. I began to see that none of these men were truly interested in God's Truth but that they were keen to restore and cash in on Mr Armstrong's (HWA) life's work despite God having allowed this to be thrown down during the 1990s by the late Mr Joseph W Tkach. Surely there must be one minister willing to restore the OT LORD God to the Church of God. How can members of the former WCG who don't care be the Elect of God?

A review of the 18th lesson of the 58-lesson correspondence course or a review of the 17th lesson of the 32-lesson Bible Correspondence course should leave the reader in no doubt that the former WCG taught that Jesus married Israel under the Old Covenant. Therefore let no one question that the former WCG taught that the NT Jesus was the OT Husband of Israel. Indeed these lessons refer to that marriage as Jesus' first marriage. The WCG also taught that when at last Israel repents and returns to Him, Jesus will remarry His OT Wife Israel (Hosea 2:2, 7, 14, 16, 19, 23). In addition the NT teaches that the NT Church of God is the Bride of Jesus. Therefore the former WCG taught that our Lord Jesus will be involved in at least two marriages and a betrothal. Again a necessary consequence of all this is that God the Father remained throughout an unmarried Father.

This returns us to the earlier question which is addressed in this article. Yet many will ignore the enormous mountain of evidence from the Bible and insist that the WCG under HWA could not have been in error on the important issue of our Father in Heaven's OT identity and His marital status. They should ask themselves whether the witnesses I cite, our Lord Jesus, Peter and Paul, were in error rather than HWA.

There comes a time when we must decide between God's inspired Bible truth and a faulty human interpretation but without losing respect for God's 20th-century servant HWA. Mr Armstrong did much of his early work without any assistance whilst at the same time publishing The Plain Truth magazine, conducting regular radio broadcasts, ministering to a growing flock and later opening a virtual university in the form of Ambassador College and who converted us from mainstream Christendom to the Truth of the Bible.

The writer rejects Unitarianism, God is a Family (a pseudo Binity) and Trinity but recognizes from the Bible the original independent and self-existent deities of both the NT God the Father and His incarnate Son Jesus but which independence and self-existence Jesus surrendered to become and die as our atoning Passover Lamb and an obedient Son to his original fellow God.

Before we can know God the Father's OT identity and Jesus' surrender of His original deity to become incarnate and die as our Passover Lamb we must understand the following:—

- 1. The Hebrew noun "Elohim" (God, Strong H430) is always singular when it refers to the true God of Israel.
- 2. How did the OT fathers and prophets hear His Father when Jesus said no one had heard or seen His Father (John 5:37)?
- 3. Who is the OT LORD God who declares there is no God beside Him (Isa 45:5)?
- 4. Who is the most high LORD God of Abraham, possessor of heaven and earth (Gen 14:22)?
- 5. Who was Melchizedek priest to the most high God of Abraham (Gen 14:18) and who had neither father nor mother nor beginnings of days (Heb 7:4)?
- The full extent of Jesus' sacrifice can only be understood when this is seen to include the surrender of His original independent self-existent deity so that His Father now remains as the only true God (John 17:3).
- 7. The all-capitals form "LORD" denotes God the Father's unique sacred name JHVH (YHWH), which means "The Eternal" and is not the commonplace title "Lord".
- 8. The first occurrence of the phrase "LORD God" in the Bible and why is this not found in Genesis chapter 1.

Once these are understood the absurdity of both Unitarianism and Christendom's Monotheism in the form of either a *Trinity* or the former WCG's "*God is a Family*" (a type of Binity) will become clear and the fuller extent of Jesus' sacrifice can at last be appreciated.

1. God (Hebr. "Elohim") is singular!

The former WCG taught that the Hebrew noun "Elohim", when this refers to the true God of Israel and is translated God, is a uniplural noun. For example, in Gen 1:26, "And God said, . . ." that the Hebrew noun "Elohim" (English "God" Strong H430) denotes a multi-Person Godhead comprising currently God the Father and His Son Jesus.

This claim may seem reasonable because "Elohim" has the outward appearance of a plural masculine Hebrew noun. Further the continuation of Gen 1:26, with the first person plural pronouns "us" and "our", seem to support the alleged plurality of "Elohim": **Gen 1:26—**"And God said, 'Let <u>us make man in our image and after our likeness</u>"."

However, appearances can be deceptive because throughout the Hebrew OT the noun "Elohim", when this denotes the true God of Israel, has the grammatical force of a singular Hebrew noun and then governs singular Hebrew verbs and singular Hebrew pronouns. Below it will be shown that those plural pronouns "us" and "our" of Gen 1:26 are not governed by "Elohim" (God) but denote jointly the singular God (Elohim) speaking and the One He addressed in Gen 1:26.

For example let us consider side by side:

And God said, let us make man in our image And Tom said, let us make dolls in our image Since the plural pronouns "us" and "our" do not render Tom plural so in Gen 1:26 these pronouns do not render either the English "God" or the Hebrew "Elohim" plural.

As a result in the Hebrew of Gen 1:26, "And God said, . . ." the Hebrew verb translated "said" is singular, thus showing that "Elohim" governs a singular Hebrew verb and therefore, like "Tom", is a singular noun and not a plural noun as Trinitarian Christendom and the former WCG taught.

Indeed in Gen 1:29 the Hebrew noun "Elohim" (God, Strong H430) again governs the singular Hebrew verb translated "said" as well as the singular personal pronoun "I" and which both show that Elohim is singular.

Gen 1:29—"And God said, Behold, <u>I</u> have given you every herb bearing seed . . .".

It is wrong to teach that God (Elohim) is a plurality of Persons by saying "God is a Family". Man ought not to define what God is but depend on what the Bible says He is. It is fine to say that God the Father <u>has</u> a Family but it is wrong to say that God the Father <u>is</u> a Family.

God the Father's Family consists currently of His still wayward Wife Israel and their Son Jesus! The reader should compare that with the errant teaching by the former WCG that God the Father is a Family that currently comprises God the Father and His Son Jesus.

2. How was the Father heard in OT times? But how can it be that the NT God the Father

But how can it be that the NT God the Father spoke to the patriarchs, Adam, Enoch, Noah, Abraham, Isaac, Jacob and Moses seeing Jesus said in John 5:37 that no one has seen or heard His Father?

John 5:37—"And the Father himself, which hath sent me, hath borne witness of me. Ye have neither heard his voice at any time, nor seen his shape."

I show how in paper P10, *How God the Father Was Seen and Heard!* The point is that no one has truly listened to God the Father, and even Moses saw only a similitude of God the Father and never His shape (Num 12:1-8).

Moses was one of God's more faithful servants but even Moses did not always obey (hear) God the Father. Although God commanded Moses to have all males born in the

desert circumcised on the eighth day (Lev 12:1-3), Moses neglected to have this done and as a result at Gilgal Joshua was required to correct Moses' omission (Josh 5:1-9).

In John 5:37 Jesus refers to man's customary failure to listen to or obey God the Father but that does not preclude God the Father having spoken to the OT patriarchs and prophets starting with Adam.

Note how Israel refused to listen to God the Father immediately after He gave the Ten Commandments:

Exod 20:19—"And they said unto Moses, Speak thou with us, and we will hear: but let not God speak with us, lest we die."

Therefore God the Father told Moses He would send a Prophet (Deut 18:15-20) with his message and Peter identified this Prophet was Jesus (Acts 3:20-23).

3. "There is no God beside me"!

If Jesus was the LORD God of the OT as taught by the former WCG, then what are we to make of OT verses where the LORD God states there is no God beside Him? If Jesus indeed gave that message through the Prophet Isaiah, then He would be denying the deity of His NT Father.

Isa 45:5—"I am the LORD, and there is none else, there is no God beside me: . . ."

Surely it is inconceivable that the NT Jesus would have denied His Father, and once again we must question that the NT Jesus was the LORD God of the OT.

If on the other hand the NT God the Father had given that message through the Prophet Isaiah, then did He deny the deity of His NT Son Jesus? The former WCG tried solving this difficulty by declaring (1) the Hebrew noun "Elohim" translated "God" (Strong H430) being a uni-plural noun and (2) that this uniplural noun denotes that the true God of Israel is a Family, which currently consists of the NT God the Father and His NT Son Jesus.

Now there is no justification anywhere in the Bible for stating that "God is a Family" and in truth that teaching by the former WCG amounts to teaching a pseudo Binity that parallels mainstream Christendom's Trinity.

It is not difficult to see that a major Godhead misunderstanding is behind this attempt to define the Godhead by teaching that God the Father is a Family. Man ought not define what God is because only God can state what He is. It so happens that on the available biblical evidence we may say instead that God has a family, which currently comprises God the Father, His still wayward Wife Israel and their Son Jesus—see at my Home Page my article A15, "Should we say 'God is a Family?' or 'God the Father has a family'?" and which was published on page 11 of Issue 145 (Sept 2011) of The Journal.

4. The most high LORD God of Abraham

After Abraham had virtually offered his son Isaac, the LORD God said Abraham,

Gen 22:16—"And said, By myself have I sworn, saith the LORD, for because thou hast done this thing, and has not withheld thy son, thine only son:"

Paul explains this in Hebrews 6:13,

Heb 6:13—"For when God made promise to Abraham, because he could swear by no greater, he sware by himself,"

From this we may conclude that the LORD God who spoke to Abraham was the most high LORD God of the OT and therefore the NT God the Father.

This is also the LORD God who spoke to Moses from the Burning Bush as testified by Jesus and Peter. Let us begin with Peter's testimony,

Acts 3:13—"The God of Abraham, and of Isaac, and of Jacob, the God of our fathers, hath glorified his Son Jesus . . ."

Let us link this with Moses's testimony,

Exod 3:6—"Moreover he said, I am the God of thy Father, the God of Abraham, the God of Isaac, and the God of Jacob. And Moses hid his face; for he was afraid to look upon God."

Then let us remember that "God" (Strong H430, Hebrew Elohim) is singular and, since Peter equates this to the God with a Son and hence with God the Father, we must conclude that the God speaking to Moses from the Burning Bush was God the Father.

This is also clear from Jesus teaching the Sadducees as follows:

Mark 12:26—"And as touching the dead, that they rise: have ye not read in the book of Moses, how in the <u>bush</u> God spake unto him, saying, I am the God of Abraham, and the God of Isaac and the God of Jacob?"

Mark 12:27—"<u>He</u> is not the God of the dead but the God of the living: ye therefore do greatly err."

That in Mark 12:26-27 Jesus was inferring His Father had spoken to Moses from the (Burning) Bush follows from His using in verse 27 the underlined third person singular pronoun "He". It is clear that Jesus was not referring to himself but to His Father as the OT LORD God who spoke to Moses.

This is also obvious when Jesus discusses with the Jews their God of the OT and identifies Him with His Father: for example in John 8:54.

John 8:54—"Jesus answered, If I honour myself, my honour is nothing: it is my Father that honoureth me; of whom ye say, that he is your God:"

This is also seen in James 1:1 and many other NT verses.

Jam 1:1—"James, a servant of God and of the Lord Jesus Christ..."

This should have been obvious to anyone reading the NT, including Mr Armstrong, but it wasn't. My paper P1, *Laodicea's Lamp!* essays the reason God blinded HWA to this truth.

Readers should avoid fooling themselves that HWA could not have erred on the OT identity of God the Father because in the end that would mean that Jesus and Peter and Paul too would not have known the OT identity of God the Father.

Additional proof that God the Father was the Creator and LORD God of Exodus and the OT is given in articles Q6, Q7, A2 with A3, A4, A13 and the study paper P2, God the Father is the Creator and Husband of Israel—which are all available at my Home Page.

5. Melchizedek, priest to the Most-High God

The NT God the Father and the NT Son of God, Jesus were both known to Abraham. God the Father was the most-high LORD God who spoke to Abraham on several occasions. The apostle Peter explains in Acts 3:13 that the *God of Abraham, the God of Isaac and the God of Jacob* was the Father of Jesus.

Acts 3:13—"The God of Abraham, and of Isaac, and of Jacob, the God of our fathers, hath glorified <u>his Son</u> Jesus..."

Exodus 3:6 shows that Moses met this most-high God when He appeared to Moses at the Burning Bush in Exodus 3:6.

Exod 3:6— "Moreover he said, I am the God of thy father, the God of Abraham, the God of Isaac, and the God of Jacob..."

Genesis 14:18 shows that Melchizedek was priest to the most-high LORD God who met Abraham.

Gen 14:18—"And Melchizedek king of Salem brought forth bread and wine: and he was the priest of the most high God".

Hebrews 6:20-7:4 identifies Melchizedek who met Abraham as the God who became incarnate as the NT Jesus. This is obvious from Paul's inspired description of the titles King of Righteousness (Melchizedek) and King of Peace (Salem) which can only apply to Jesus.

Since the Melchizedek who met Abraham had no human descent (no father or mother) and had no beginning of days or end or life when He met Abraham, He was not a created angel or man but can only have been an independent self-existent God alongside His

Heb 7:1—"For this Melchisedek, king of Salem, priest of the most high God, who met Abraham returning from the slaughter of the kings, and blessed him:"

Heb 7:3—"Without father, without mother, without descent, having neither beginning of days, nor end of life, but made like unto the Son of God abideth a priest continually."

For a fuller explanation see Article A12 at my Home Page or on page 25 of Issue 139 of The Journal (June 2010).

This is further supported in King David's Psalm 110 in which God the Father addresses Jesus as David's future Lord Jesus.

Ps 110:1—"The LORD said to my Lord, Sit thou at my right hand, until I make thine enemies thy footstool."

Ps 110:4—"The LORD hath sworn, and will not repent, Thou art a priest for ever after the order of Melchizedek."

The Unitarian nonsense that is finding increasing acceptance amongst members of the former WCG vainly attempts to get around the inspired messages of Hebrews 7:1-4 and Philippians 2:5-7.

Php 2:5—"Let this mind be in you, which was also in Christ Jesus:"

Php 2:6—"Who, being in the form of God, thought it not robbery to be equal with God."

Php 2:7—"But made himself of no reputa-

tion, and took upon him the form of a servant, and was made in the likeness of men."

6. The fuller extent of Jesus' sacrifice.

The inspired descriptions of Melchizedek in Hebrews 7:1-4 can apply only to a God and not to a created Being such as angels or man. Although angels have neither father nor mother, they do have a beginning of days because they were created. Therefore the Being who met Abraham as Melchizedek and was priest to the most high God (Father) was the NT Jesus and was not an angel but was originally an independent self-existent God himself.

Therefore Melchizedek, who was priest to the most high God, was a God himself but obviously was not God the Father but was the God who was made incarnate as the NT Jesus. See article A4 for a detailed explanation, which appeared on page 14 of Issue 149 of The Journal (May 2012).

Therefore Hebrews 7:1-4 utterly refutes the Unitarian nonsense that arose during the 2nd century AD and which detracts from the fuller extent of Jesus' sacrifice to become incarnate and die as mankind's atoning Passover Lamb and being made for ever an obedient Son to his fellow God and now his Father.

7. God the Father's unique sacred name.

At Moses' request the LORD God (Father) gave His unique sacred name.

Exod 3:13—"And Moses said unto God, Behold, When I come unto the children of Israel, and shall say unto them, The God of your fathers hath sent me unto you: and they shall say to me, What is his name? what shall I say unto them?"

Exod 3:14—"And God said unto Moses, I AM THAT I AM: and He said, Thus shalt thou say unto the children of Israel, I AM hath sent me unto you."

In Hebrew God's unique sacred name "I AM THAT I AM" is denoted by the Hebrew Tetragrammaton JHVH (also YHWH). Only the four Hebrew consonants of His name have survived as that Tetragrammaton. The reason being that originally the Hebrew text recorded only consonants and no vowels and no one dared say the sacred name. As a result the vowels of the sacred name became lost and with that also the sacred name. Only the recorded four Hebrew consonants (JHVH) have survived in the Hebrew OT, as the Tetragrammaton where it occurs over 6,500 times.

Exod 6:2—"And God spake unto Moses, and said unto him, <u>I</u> am the LORD:"

Exod 6:3—"And <u>I</u> appeared unto Abraham, unto Isaac, and unto Jacob, by the name of God Almighty, but by my name Jehovah was <u>I</u> not known to them."

The pronouns "I" show only one God spoke.

God the Father's name means *The Self-existent One* or *The Eternal* and since the God speaking calls himself "God Almighty" He was God the Father.

This unique sacred name of God the Father is denoted in the Hebrew OT by the Tetragrammaton (the four Hebrew letters) JHVH (or YHWH) but this is variously represented in English as the all-capitals forms "LORD" or "GoD" and even as Jehovah (see Exod 6:3 abova)

In English translations the Tetragrammaton is mostly depicted by the all-capitals forms "LORD" (Strong H3068) and "GoD" (H3069).

This is fully explained in article A13, "How the OT Lord, God and God Relate to God's Name and His NT Identity" at my Home Page and was published on page 16 of Issue 154 of The Journal (August 31, 2013).

It is recommended that when reading in the OT the all-capital forms "LORD" and "GOD" that instead we read "The Eternal" because that is the literal meaning of God the Father's unique sacred name. Let us not read "Lord" but "The Eternal" because there is no place for turning God the Father's unique sacred name into the commonplace title "Lord" despite the KJV translators having rendered

His unique sacred name by the all-capital forms "LORD" or "GOD". The reader is urged to study my article A13 and not assume he already understands the matter.

It is explained in article A13 that God the Father's unique sacred name—The Eternal—can only apply to God the Father and not to any created being, such as the angels, or to even God the Father's Son Jesus. It cannot apply to Jesus because Jesus surrendered for all future eternity his former independent self-existent deity to become and die as mankind's atoning Passover Lamb.

Jesus was without existence for 3 days and 3 nights and depended on His Father to restore Him to life again. He now remains for all future time an obedient Son to His Father.

Therefore Jesus is no longer a true independent self-existent eternally existent God. Only His Father remains an independent self-existent eternally existent God and therefore only to God the Father belongs the unique sacred name JHVH which means The Eternal and is denoted in English by the all-capital forms "LORD" or "GOD".

Only God the Father can be "The Eternal" and no other. Therefore when we see in the English OT the all-capital forms "LORD" or "GoD" we must recognize that these refer to the NT God the Father and to on one else.

Further that the all-capital form "LORD" detracts from God the Father's unique sacred name "The Eternal" (I AM) and reduces it to a mere commonplace title "Lord" which frankly is blasphemy!

8. First occurrence of the phrase "LORD God".

Note that Genesis chapter 1 does not refer to the phrase "LORD God" but only to "God" (Heb. Elohim, Strong H430). The first time we find the expression "LORD God" is in Genesis 2:4. That is after God the Father put that question in Genesis 1:26 to His fellow God (NT Jesus) and Jesus must have confirmed His commitment to be made incarnate and die as our atoning Passover Lamb.

Up to that point there were two independent self-existent eternally existent God Persons but with that commitment in effect only God the Father remained as the one and only independent self-existent eternally existent God Person. As a result of his commitment to become incarnate and die as man's atoning Passover Lamb, this God surrendered His former independent self-existing eternally existing deity. This God also accepted becoming for evermore an obedient Son to His fellow God and Father.

Therefore God the Father is the only remaining independent self-existent eternally existent God who could give himself the unique sacred name JHVH (The Eternal) and which the KJV translators denoted by the all-capital forms "LORD" or "GoD". It is not surprising the form "LORD God" appears only after Jesus made that commitment in Genesis 1:26 and so allowed God the Father to create Adam and Eve in their image.

Gen 2:4—"These are the generations of the heavens and of the earth when they were created, in the day that the <u>LORD God</u> made the earth and the heavens."

Although the forms "LORD God" appears from then frequently throughout the rest of Genesis; Abraham, Isaac and Jacob did not know God by His name (Exod 6:3). This was probably because they did not ask for God's name but which Moses did ask in Exodus 3:13 and was given the LORD God's name in Exodus 3:14—see Section 7, *God the Father's unique sacred name*.

9. The Godhead taught by the former WCG. The WCG under HWA taught that the NT God the Father and His NT Son Jesus are both God Persons but that Jesus had been made

God Persons but that Jesus had been made incarnate to become and die as mankind's atoning Passover Lamb.

HWA agreed with Mainstream Christendom that Jesus had created the physical worlds including Adam and Eve. He went a little further in stressing that Jesus as the LORD God of

Exodus had married the nation of Israel in the Old (Marriage) Covenant at Mt Sinai.

To cope with apparent Unitarian scriptures such as Deut 6:4 and Isa 44:6, 45:5, which state there is only one God, HWA taught that *God is a Family*, which at present comprises God the Father and His Son Jesus. In other words HWA taught a kind of Binity (Cp Trinity) Godhead by claiming that God is a Family. Man needs to be careful when defining what God is or isn't and especially when this is not explicitly stated in the Bible. Indeed nowhere does the Bible state that God is a Family.

HWA also claimed that the Hebrew noun for God (Elohim Strong H430) is uni-plural in support of his claim that "God is a Family". This helped him with those aforementioned apparent Unitarian scriptures because then it could be claimed God (Hebrew Elohim) includes two God Persons.

However the Hebrew OT reveals that Elohim (God, Strong H430) is always singular in reference to the true God of Israel. The true God is Israel's Husband and therefore must be the NT God the Father. This is supported in prayer by Jesus when He referred to His Father as the "only true God".

John 17:3—"And this is life eternal, that they might know thee <u>the only true God</u>, and Jesus Christ, whom thou hast sent."

The point being that the Church of God did not know that God the Father was the only true God. It was not realized that when Jesus agreed to be made incarnate and die as mankind's atoning Passover Lamb He from then ceased being an independent self-existing eternally existing God Person. It is true that Jesus lost only 3 days and 3 nights from his original eternal existence but it was nevertheless a gap that stopped him being another Eternal besides his Father.

Once Jesus made that commitment (Gen 1:26) it was as good as done and He was from then no longer a true independent self-existent eternally existent God. However, He did retain his original God mind as we can see from Philippians 2:5-7,

Php 2:5—"Let this mind be in you, which was also in Christ Jesus:"

Php 2:6—"Who being in the form of God ..." Php 2:7—"But made himself of no reputation, and took upon him the form of a servant, and was made in the likeness of men:"

Note the significance of Genesis 1:26.

Gen 1:26—"And God said, Let us make man in our image after our likeness..."

In this the God Person speaking (Father) addressed another God Person (the one who became incarnate as the NT Jesus). God (Father) did not address any angelic being because man was made in the image and likeness of God and not in the likeness of an angelic being. So when God the Father refers to our image He was addressing His fellow and then still independent self-existing God.

It was this fellow God's last opportunity to withdraw from the commitment to become incarnate and die as mankind's atoning Passover Lamb. Only when He (NT Jesus) agreed could his fellow God (NT Father) go ahead with the creation of Adam and Eve.

The NT states several times that God (Father) created the worlds, ages, etc, through Jesus. This does not mean Jesus did the creation but that God the Father could create the Adamic world only as a result of Jesus commitment. It is plain from Genesis 1:27, 29 and Gen 2:4 that just one God did the creating and He was the God who addressed Jesus in Genesis 1:26.

Gen 1:27—"And God created man in <u>his</u> own image, in the image of God created <u>he</u> them: male and female created he them."

Gen 1:29—"And God said, Behold, <u>I</u> have given you every herb bearing seed . . ."

Dark Star (2011) by Henry Stevens

Hidden History of German Secret Bases, Flying Disks & U-Boats: In 1955 Karachi, Pakistan, thousands of mostly Pakistanis and some British military saw a glowing orange disk. It moved then hovered 40 yards high. The hull resembled two bronze cymbals, 150 feet in diameter and 75 feet high. It looked manmade with rivets, catwalks, portholes and ladders.

Wendell Stevens (no relation), then a US Air Force Colonel, was tasked with filming UFOs in the Arctic, in stripped down bombers equipped with cameras. The films were sent to Washington DC, but he had no feedback. He believes they were Nazi craft, and he speaks at

UFO conferences.

Karl Doenitz said "The German submarine fleet is proud of having built for the Fuehrer in another part of the world a Shangri-la on land, an impregnable fortress... The German navy will have to accomplish a great task in the future. It knows all the hiding places in the oceans and therefore it will be very easy to bring the Fuehrer to a safe place should the necessity arise." Nazi bases were found in Greenland and kept secret with a device that

skewed magnetic compass readings.
William Lyne claims "Today, flying saucer bases such as the huge underground base built in Greenland are probably maintained under joint Trilateral/ex-Nazi control." He claims 24 Uboats were ready to attack the US with nuclear missiles, so a deal was cut for the US to save half of Germany for the Nazi homeland. Many Nazis were allowed amnesty [and hired in the US to continue their criminal activity], and the atom bomb was conveyed to the US on board a U-boat.

Admiral Byrd led a US fleet to Antarctica for 'research' in 1958. He warned that "in the event of a new war the US would be attacked by flyers who would be able to fly from one pole to the other with fantastic speed." He exploded atom bombs, claimed for air tests as those in Nevada at the time, to supposedly recover land from the ice layer. They were really to fry electronics with EMPs, but the Nazis shielded sensitive devices with metal coverings. Many flying disks were seen in the area during those years. Disks flights were seen over Washington DC in 1952—a warning?

Just before WWII, Nazis sent an expedition to

Antarctica, finding warm water lakes fed from geothermal vents. This Neuschwabenland is on the coast just south of the tip of Africa where they were able to grow vegetables. William Landig wrote they were forced to leave when their immune systems became weak from the sterile environs so were subject to fatalities from the common cold, and they moved to South America where some were already settled.

Dr. Salla reported on Nazi mind control experiments that were later carried on by Nazis in CIA employ to produce super soldiers. One subject told how he was led to believe by hypnotic trances that he could do great feats by thinking they were just small ones as jumping off a stool while jumping out of airplanes without a chute. He could do whatever they said if he believed them, as 200 pushups or lifting 1500 pounds. [Like the adage Anything the human mind can conceive and believe, it can achieve.]

The Nazi U-boat base in the movie *Raiders* of the Lost Ark is real at Fuerteventura in the Canary Islands, denied by most islanders in public but confessed in private. It had two Uboats used to at least 1950.

When Mussolini was captured by Italians, Hitler sent Skorzeny with a team to free him. They barely escaped. Mussolini was clutching a briefcase, but had to leave it behind. The Nazis got the papers inside and found they were letters from Churchill as if they were pen-pals. Mussolini planned to use the letters to black-mail Churchill to save himself if necessary. [Britain was really directing Hitler and Mussolini, but they later went rogue.

Post-war Nazi production of flying disks could be much by contracting out for parts and assemblies from ordinary companies without causing suspicion. And work done in underground plants as during the war.

U-boats were fitted with flying disk technology so they could fly or submerge. The free energy golden age of flying disks was 1940-1970. U-boats used diesel engines on the surface and to charge their batteries, but were unaffected by battery-use underwater. Tesla envisioned submarines with a trailing antenna a mile long to receive energy supply from afar, as radio signals, using ELF waves with long wave lengths. He later perfected a shorter antenna, compacted. Energy could be supplied to any point on the globe. Many of his inventions are still kept secret.

Nazi Reinhard Gehlen agreed with the US to

form an organization that would continue spying. The US and Nazis agreed to work in cooperation with each other, but when US-Nazi interests diverged, the new "organization would consider the interests of Germany first."

Jesuits—the Vatican Assassins

Jesuit James Marquette's statue is in the Capitol. Why is a Jesuit so honored?

Lafayette said about Jesuits "It is my opinion that if the liberties of this country—the United States—are destroyed, it will be by the subtlety of the Roman Catholic Jesuit priests, for they are the most crafty, dangerous enemies to civil and religious liberty. They have instigated most of the wars in Europe." Rothschild hired

Weishaupt, a Jesuit, to reform the Illuminati.

Jesuits were founded by Jews, though allow some Gentiles to appear universal, while destroying Christianity. Jesuits later took over the pope, with their own 'black' pope, now 2 share power. Hitler's SS copied Jesuit ways, while he and Mussolini were both aided by the pope. The pope is the little horn (Dan 7:8), though controlled by the Jesuits. Jesuits had many US presidents killed and are aptly called Vatican assassins.

The US officially became a nation in 1789, the same year the first Jesuit school was founded, Georgetown University. Now 28 Jesuit universities are in USA, the nation with the highest Jesuit influence; 112 nations have such schools. Jesuits have a sun worship logo.

Jesuits and the pope in Vatican City are the dual-headed antichrist. The two-headed eagle of Freemasonry represents the white and black popes. "The Jesuits are Satan's greatest secret society." [The new pope is a Jesuit general.]

"England's throne has been fully controlled by Jesuits since King George III during the mid-18th century ... [He] called himself *Prince Elector of the New Holy Roman Empire*. British PM Shelburne was an actual Jesuit himself. He was a PM during King George III's reign.'

Freemason world leaders

Most all nations' rulers are top Masons, exposed when they use symbolic hand signs when greeting each other, or using certain gestures for the camera. These Masons collude to further Satan's agenda (though all want to be top dog). Even lesser Masons take blood-curdling oaths to help other Masons, even to perjure themselves in court to defend them. Highest Masons vow to avenge Lucifer.

"Masonry is based on Judaism." Rabbi Isaac Wise stated "Freemasonry is a Jewish establishment whose history, grades, official appointments, passwords and explanations are Jewish from beginning to end.

Many US presidents were 33° Masons. "Besides being taught that Lucifer is the true god, 32° and 33° Masons have their own Luciferian calendar, based on Anno Lucis (Year of Light/ Lucifer)." Dating cornerstones of Masonicbuilt edifices, as US national buildings.

Freemasonry is called the Craft and has many things in common with witchcraft. "In Freemasonry is embedded the core or the secret heart of the occult mysteries, wrapped up in number, metaphor and symbol."—Benjamin Crème

Napoleon Bonaparte was a Mason. Guiseppi Mazzini was 33° and founder of Italian Freemasonry and the Mafia, organized crime mob. Albert Pike was a supreme Mason, too, set up the KKK and is revered by Masons.

"The Illuminati is the highest echelon of Freemasonry, an occult secret society dedicated to Lucifer. The world control bankers have intermarried with the richest European monarchs and US presidents." Even a 12-year old girl traced out the royal lineage of presidents (see online). Just one big family, as Bush and Kerry are cousins.

Lucifer can be translated morning star, a term for Venus and reason for using the ubiquitous 5point star. Its orbital path traces out 5 points. Masons worship Lucifer through these stars.

John Daniel's Scarlet Beast

"It is a Masonic conspiracy, and 32° Masons have called us from all over the United States and told us it is. And the U.S. is to play the key central role in the New World Order. America is a Masonic nation, called the New Atlantis, the

The British Union Jack flag flies over the J.P. Morgan offices in the heart of Wall Street. "Since the 19th century the entire policy-making apparatus of the USA has been manipulated by the noble families of Britain, acting in concert with their Venetian and Genoese relations.

"Not only were corporations enthroned following the Civil War, but the power of Freemasonry secured the Presidency following Lincoln's assassination. [Lincoln's VP] Johnson pardoned General Albert Pike for treason and subsequently received the 4°-32° in one night in 1867.

Senator Helms spoke before the Senate 12-15-1987: "This campaign against the American people [of] systematic psychological warfare [by] the Council on Foreign Relations, the Trilateral Commission and the Bilderberger Group serve to disseminate and to coordinate the plans for this New World Order in powerful business, financial, academic and official circles.

Psychology Today quoted James McConnell. The day has come when we can combine sensory deprivation with drug hypnosis and astute ma-nipulation of reward and punishment to gain almost absolute control over an individual's behavior. It should then be possible to achieve a very rapid and highly effective type of positive brainwashing that would allow us to make dramatic changes in a person's behavior and per-

"Delgado demonstrated a prototype by putting a brain implant in a bull, which charged him till he hit a button on his hand held control [device] behind his red cape, the charging bull came to a screeching halt, turned docile and went back where it came from. Now they can do this with people, and from very long distances. They actually have the ability to use microwaves and implants to put thoughts and even voices into your mind, and to make you do anything they want.'

Banker and corporate world rule

Former Malaysia PM Mahathir Mohamed claimed "Jews rule this world by proxy, they get others to fight and die for them . . . They have now gained control of the most powerful countries . . . This tiny community has become a world power." Jew-Zionist terrorist leader Ze'ev Jabotinsky boasted: "There is only one power which really counts. The power of political pressure. We Jews are the most powerful people on earth, because we have this power,

and we know how to apply it."

Helen Thomas: "I think every president has had to bow to the whole problem of [Zionism] ... They [Zionists] used their money. They had the power—communication, propaganda—so it's been going on more than a century. There's a great purpose, to preserve Israel at all costs, aided and abetted by almost every president because they put money in campaigns and presidents owed a debt."

General Smedley Butler wrote the 1935 book War Is a Racket. In his 1933 speech he said: "I spent 33 years in active military service . . . during that period I spent most of my time being a high class muscle-man for Big Business, for Wall Street and for the Bankers. In short, I was a racketeer, a gangster for capitalism." Fascism is when corporations rule the government.

Lawrence Britt studied fascist regimes of Hitler, Mussolini, Franco (Spain) and Suharto (Indonesia) finding 14 traits (most listed here) that also apply to the US: (1) Powerful Nationalism—constant use of patriotic mottos, slogans, symbols and songs. Flags everywhere. (2) Disdain for Human Rights—For fear of enemies and security, people need to look the other way or even approve of torture, executions and long prison terms. (3) Identify Enemies or Scapegoats—rally behind patriotic frenzy over a foe. (4) Military Supremacy—highest budget, soldiers glamorized. (6) Controlled Mass Media [US media is controlled by only 5 companies now]. (7) Obsession with National Security. (9) Corporate Power Is Protected. (12) Obsession with Crime and Punishment—police given much power as the people lose civil liberties for sake of patriotism [despite liberty lauded]. (13) Rampant Corruption (top politic are corporate leaders [as Cheney with Halliburton despite its hiked prices for poor services]).

(14) Fraudulent Elections [Each year US elec-

tions show rigging as Bush vote in Florida, gained because Jeb Bush was governor. Most blatant was the 2012 election when absentee military ballots were shipped wrongly. They were found after the election in crates labeled ammo. These ballots were expected to side in favor of Romney, to swing electoral votes to elect him. The ballots were collected and shipped in the spring to avoid not getting their votes counted! Another case of poor treatment by the US government for its troops, in spite of lip service.]

US Senator George Malone in 1957 spoke before Congress: "I believe that if the people of this nation fully understood what Congress has done to them over the last 49 years they would move on Washington; they would not wait for an election . . . It adds up to a preconceived plan to destroy the economic and social independence of the U.S."

US touts freedom but imprisons (has the highest prison population) and tortures many. And (at Abu Graib and) Guantanamo, kept going despite many protests against such practices as waterboarding, and held without due process (see *Wikipedia*). The US troops involved become cruel, performing sadistic acts a psychopath would do. The info gained is unreliable, the victim will say anything to stop the torture.

The British East India Co. flag with 13 stripes is derived from the Cabala of sacred colors red, white and blue. Tests were conducted by 80 institutions: hospitals, prisons, drug companies, colleges and universities. "The CIA operated through these institutions using front organizations, although sometimes top officials at these institutions were aware of the CIA's involvement."

CIA Director Richard Helms ordered all MKUltra files destroyed in 1973, and it was officially abandoned. Though 20,000 documents survived, and it likely continues under other names.

"The CIA was also interested in being able to manipulate foreign leaders with such techniques . . . Experiments were often conducted without the subjects' knowledge or consent.'

'Some historians assert creating a Manchurian Candidate subject through mind control techniques was a goal of MKUltra." (Acting normal until given a trigger word to then perform a task, as assassinate someone.)

Heroin addicts were bribed into taking LSD and offers of more heroin . . . Experiments included administering LSD to mental patients, prisoners, drug addicts and prostitutes, people who could not fight back as one agency officer put it . . . LSD was also administered to CIA CONTINUED ON NEXT PAGE

employees, military personnel, doctors, other government agents and members of the general public in order to study their reactions. LSD and other drugs were usually administered without the subject's knowledge or informed consent, a violation of the Nuremberg Code that the U.S. agreed to follow after WWII. The aim of this was to find drugs which would irresistibly bring out deep confessions or wipe a subject's mind clean and program him or her as a robot agent.

Canadian Donald Cameron worked in the US to perfect psychic driving. Subjects were put into comas for weeks while playing looped recordings of statements or noise over and over. "His experiments were typically carried out on patients who had entered the institute for minor problems such as anxiety disorders and postpartum depression, many of whom suffered permanently from his actions." Some forgot how to talk. Others forgot their parents and thought the controllers were their parents.

It was during this era that Cameron became known worldwide as the first chairman of the World Psychiatric Association as well as president of the American and Canadian Psychiatric Association, Cameron had also been a member of the Nuremberg medical tribunal in 1946-47.

Working with the CIA, the Dept. of Defense gave hallucinogenic drugs to thousands of 'volunteer' soldiers in 1950s-60s.'

The Supreme Court noted: "The U.S. played an instrumental role in the criminal prosecution of Nazi officials who experimented with human subjects during WWII, and the standards that the Nuremberg Military Tribunals developed to judge the behavior of the defendants stated that the voluntary consent of the human subject is absolutely essential."

[The US hired many Nazis (as Dr. Mengele) to continue their evil work in the US. Though the US acted outwardly to condemn and judge these practices as wrong and crimes against humanity. Respected global leaders as Cameron were really most evil.]

Wikipedia on Unethical human experiments in the US—Regarding radiation tests on humans: "Nasal radium irradiation went on to become a standard medical treatment used in over two and half million Americans." So patients were given radiation for various reason (none good). Horrific experiments were conducted on people without their consent or were lied to about the risks. "As of 2007, not a single U.S. government researcher had been prosecuted for human experimentation, and many of the victims of U.S. government experiments have not received compensation, or in many cases, acknowledgment of what was done to them.'

"After the eugenics movement was well established in the U.S., it spread to Germany. California eugenicists began producing literature promoting eugenics and sterilization and sending it overseas to German scientists and medical professionals . . . The Rockefeller Foundation helped develop and fund various German eugenics programs, including the one that Josef Mengele worked in before he went to Ausch-When Nazis after the war were prosecuted for crimes against humanity, they cited as defense US involvement in these same things, even initiating them with Germans.

MKUltra used mind controlled people as sex slaves to blackmail high federal officials in illicit sex by filming their acts, to keep its funds coming. The CIA Project Bluebird, later named Artichoke, was to develop mind control, forced on anyone. "The purpose of the project was outlined in a memo dated Jan. 1952 that stated Can we get control of an individual to the point where he will do our bidding against his will and even against fundamental laws of nature, such as self-preservation?"

Fritz Springmeier and Cisco Wheeler on Mind Control—Dissociate in psychiatry means to separate off areas of the mind, to set apart a group of mental processes from the rest of the mind. So it becomes compartmentalized, sectioned off. Already, humans have two hemispheres which function quite differently. When traumatized, the mind focuses away from extreme pain and can become unattached from it. An awful experience can be forgotten, though the reaction to it can be manifested later in weird behavior.

It was learned that the ability to disassociate is passed genetically from one generation to the next. American Indian tribes had traumatic ritual dances and could wait motionless for hours when hunting. Children of Fakirs in India would sleep on a bed of nails or walk on hot coals. Children of Yogis (those skilled in Yoga) had total control over their body in a trance. [Some prisoners under extreme pain found they suffered less if they concentrated on a mental project of their own.]

Pavlov and Skinner pioneered behavior modification on animals, later their techniques were used on humans. Dr. Mengele was hired in the US to continue his horrific science of the Nazis, traumatizing people close to death to force his will on them. Of course, there were many deaths and the bodies were dissected to learn more. Scientific methods used controlled monitoring them to develop Multiple Personality Disorder, even thousands of alters. Many died in the process despite the 'exact' science developed.

"The MC victim can be programmed with thousands of alter personalities and function in thousands of different capacities. [In Mark 5:2-13 a demon-possessed man was called Legion (4500-6000) and resulted in 2000 dead pigs).] Programmed alters can fluently speak in another language (unknown to the front alter), or physical body traits can change radically (deeper voice, more strength, endurance to pain), or possess a photographic mind . . . yet be highly forgetful when using the front personality

When the Master dies, the slave tends to die also from suicide-programming installed. The Master is loved by the slave. Similar to the Stockholm syndrome—the captive dependent on the Master, loves him despite the horrid treatment. Mengele was known to his victims as Daddy and loved by them.

"Sleepers-there are millions of MC programmed individuals here in America who will be used during the 'end times' scenario to create massive chaos and destruction so as to justify the imposition of martial law and eliminate perceived enemies of the Illuminati (you)."
"The Illuminati and the Mob have controlled

Hollywood [telling much in films as Telethon and Manchurian Candidate a lot of slaves are actors, Madonna and Marilyn Monroe, each a programmed multiple . . . Anton LaVey, head of the Church of Satan, was a mind control programmer and very close with Hollywood.

The "music industry here in the USA is actually an intelligence front for the Illuminati . . . songs played over the radio are used in triggering mind controlled slaves.

High ranking Freemason and Rosicrucian leader Swinbourne Kleimer in Ancient Mystic Oriental Freemasonry told of a secret body that ruled all the various ancient mystery religions in the ancient world. The Illuminati continue that body. "Freemasonry is the outer symbol of the ancient mystery religions."

"In Australia this madman went in and he gunned down a lot of innocent people—children and families. Right after that they ram-rodded through gun legislation and about half a million weapons were turned in without a fight by Australians because of this horrendous massacre. The same things are going to happen in this country." Mock terrorism by the state to confiscate guns and begin martial law. Many policies started in Australia are slated for the rest of the world, too.

'Admiral Stansfield Turner on 8-3-1977 told the Senate Investigating Committee that in the USA, prisons, drug companies, hospitals, medical colleges, universities and corporations were helping the CIA carry out mind control and using the slaves for tasks."

Monarch programming: "The Monarch but-terfly learns where it was born and it passes this knowledge via genetics on to its offspring. This was one of the key animals that tipped scientists off, that knowledge can be passed genetically. The Monarch program is based upon Illuminati and Nazi goals to create a Master race in part

"Illuminati created the CIA: Satanists within the CIA took over Boy's Town, New England, in the early 1950s and used that orphanage for a constant supply of boys for programming . . . there are whole long list of other orphanages [involved]." [FBI head Gunderson investigated Satanic rituals at a school. Finding tunnels underneath, that sacrifice of small animals was shown in front of kids. The children were not believed at first, so the perpetrators almost got away. He found other schools were also involved with pedophilia.]

Primary and initial torture of children in western US (as Charles Manson) was at China Lake, California. Part of tests labeled New Weapons—as 'human robots' turned out in large numbers. The kids were first locked in electrified cages or Woodpecker Grids, trapped as animals to train them. Top US leaders sacrifice some of these slaves as victims at Bohemian Grove rituals. [They pretend mock sacrifices, but actually do human ones. About 800,000 children go missing each year in the US. Of course, not all due to sacrifices.]

The CIA ran mind control experiments at Jonestown, Guyana. Survivors told of gruesome drug tests and one footlocker alone had 11,000 doses So the many deaths were not from mass suicide.

The power of hypnosis is often underrated because the power of the mind is underrated. The mind can decide to control its breathing, heart beat, blood pressure and other things that were once thought to be involuntary only. The brain produces a substance which is a tiny peptide molecule called enkephalin which acts just like morphine and reduces pain. The brain can be hypnotically trained to release enkephalin so that the brain doesn't perceive pain. Drugs are used to facilitate hypnosis. Modern drugs do almost all the work for the hypnotist. They place the person in an altered state and make them willing to take any order.'

Order of Osiris: "One of the secrets of the mystery religions was the ability to use drugs and torture to create multiple personalities. The word Oz is known to have been used by its author as an abbreviation for Osiris. Monarch victims have the golden [part] of Osiris placed into them. The Grimm brothers were cabalistic Jews who gathered folk occult stories together. Their stories are full of spells, trances and drugs. Sleeping Beauty is put to sleep, and the trigger to wake her is a kiss on the lips

L. Frank Baum, a member of the Theosophical Society, wrote 14 Oz books. Was inspired by a spirit to write the *Wizard of Oz* book that came out in 1900. "The book's story is full of devilish activity and thinking, and chosen in late 1940s as the basis for Illuminati-Intelligence community's trauma-based total mind control programming. In Baum's time the head of the Theosophical Society was Blavastsky who put out her journal called *Lucifer*."

The Royal families of Europe are secret Satanists, from powerful occult bloodlines." (Depicted on the US Great Seal by the pyramid's 13 steps.)

In the mind set of Satanism, reality and fantasy are blurred, as in brainwashing. The brainwashed have trouble differentiating the two. [Satan encourages people to live in a fantasy world.]

"One nurse quit the University Hospital be cause newborns were secretly given implants. A few years ago it was discovered that Upjohn, an American multinational company, was involved in placing radio-transmitting material in with their liquid cortisone preparation Depomedrone.'

"Under stress, the brain converts nerve signals into messenger molecules that direct the endocrine system to produce steroid hormones, which reach the nucleus of various cells and cause them to change how the body's genes are written out . . . to make a variety of molecules which are used in growth, metabolism, sexuality and the immune system. In other words, the mind can rewrite genetics. This was the secret that helped get the Monarch program off to its scientific foundation.'

"According to Dwight Kinman's book *The World's Last Dictator*, VISA has begun issuing VISA cards using the BEAST 18-digit number. When an American makes a bank transaction on an auto teller, the BEAST has been informed of the activity. These computers use UNIX." The BEAST computer (actually many in different places) is used to record all electronic transactions.

Cisco: "The New World Order is a body of people within the Illuminati, 13 major bloodlines that rule the world and they set the stage, they play out the script and there will be a complete fulfillment of what they have staged for the American people, Canadians and the world.' Illuminati think they are gods. "If you are not generational, you are not going to get into the Illuminati because this is passed from generation to generation from son to daughter to son." Cisco knows from her own mind slave experience firsthand that "US presidents are rotten". pedophiles, drug addicts, high magic, even sacrifice live small children.'

Fritz notes that traumatizing a person keeps them in survival mode. "Syntel. That's short for synthetic telepathy which means sending to vic-

tims voices and thoughts . . . electronically." Wikipedia on the CIA—Influencing public opinion: "The Office of Public Affairs is often in charge of creating state-funded propaganda for the masses. Such as the 9/11 counter terror administration advises the Director of the CIA on all media, public policy and employee communications issues relating to this person's role. This office, among other functions, works with the entertainment industry."

"This article does not address . . . possible

illegal domestic surveillance. Nor psychological warfare in support of covert or military action.

The CIA use of mass media manipulation was leaked out, from Congress's Pike Committee investigating the CIA: "The CIA, as no doubt every other major intelligence agency in the world, has manipulated the media. Full-time foreign correspondents for major U.S. publications have worked concurrently for the CIA . . . 'stringers' and others with whom the Agency has a relationship are often directed to insert Agency-composed 'news' articles into foreign publications and wire serves. U.S. intelligence officials do not rule out the possibility that these planted stories may find their way into American newspapers from time to time, but insist that the CIA does not intentionally propagandize in this country."

If a movie came out against the CIA, movie studios used to bury it quickly, but not any more, since they can garner big bucks. "In 2012, Tricia Jenkins released her book *The CIA in Hollywood:* How the Agency Shapes Film and Television . . [that] documents the CIA's efforts at manipulating its public image through entertainment media . . . CIÂ has used motion pictures to boost recruitment, mitigate public affairs disasters.

Human rights concerns: CIA "tactics have included torture, funding and training of groups that would later participate in killing of civilians . . . overthrowing democratically elected governments, human experimentation and targeting killings and assassinations.

Drug trafficking: "CIA involvement in narcotics trafficking across the globe, although the CIA officially denies such allegations . . . numerous soldiers participated in transport of Southeast Asian heroin to the U.S. by the airline Air America. [Including drugs for US addicts stuffed in US corpses of troops shipped back in

Rep. Nancy Pelosi "stated that the CIA repeatedly misled the Congress since 2001 about waterboarding and other torture."

'U.S. Intelligence Chief Dennis Blair testified before the House Intelligence Committee on Feb. 3, 2010, that the U.S. intelligence community is prepared to kill U.S. citizens if they threaten other Americans or the United States. The American Civil Liberties Union has said this policy is *particularly troubling* because U.S. citizens retain their constitutional right to due process even when abroad.'

[NBC TV news announced in April 2013 about the Bush legacy: He invaded Iraq on bad intel, Saddam did not have WMD. So at least half his wars were unjust, naked aggression (to exploit their natural resources.)]

separate ourselves from our mates by our actions, and by our lack of forgiveness.


Our mates may be adding bricks to the wall by their offenses against us. But we can overcome those bricks with our forgiveness of those

Prophecy Today

ost Sabbath observers have an interest in the topic of prophecy.

These same believers feel that their specific church organization has a relatively clear understanding of what is going to take place in the future—at least to the extent that their ordained ministers have told them.

But is there really an understanding of what will take place in the future? Or have the "COG" prophets been deceived?

Read on, and then consider. It would seem that the most common teaching of today's "prophets" centers on the following scenario. There is coming a time when foreign armies (primarily a revived Roman Empire) will invade the present-day nations of Israel and will defeat them. Multiple millions will be killed, and any who live through this warfare will be taken into captivity where they will be persecuted and a majority will be killed.

This scenario basically began with a man named Herbert Armstrong and was propounded through his church, the Worldwide Church of God.

But, as most do not realize or will not admit to themselves, Herbert Armstrong was, according to scriptural instructions, a "false prophet." As Scripture also shows, any who continue to teach the

Armstrong theories are also "false prophets."

again have to leave their new homelands.

But it will not be as a result of warfare (though there may be a lot of "warfare" within the nations' themselves).

They will not go into forced captivity, at least not the great majority of those who live through the punishments that are coming. Any who are scattered through the nations will basically not be "persecuted" and murdered—at least as we are shown in Scripture.

Actually, the future state of the peoples of Israel is nothing like what the "false prophets" tell us today. What will take place is something that few, if any, will believe.

But, when their future situations do come to pass, they will know that the happenings were predicted, and then they will act on such predictions.

There will be a future fulfillment of the words of Amos 3:7: "Surely [God Almighty] will do nothing, unless he reveals it to his servants, the prophets"!

The True prophets are not yet "crying aloud." But they will. They will be few, as opposed to the many "false prophets"—the false prophets who are speaking lies today and will speak lies in the future.

In Part 2 (at the bottom of this page), I begin to examine the beginning of the future as prophecy tells us it will come about.

ing that what happened to the nations of Israel in Old Covenant times will happen to them again in the future.

But is that true? Does Scripture actually tell us this? You may be surprised.

We know that the peoples of Israel were punished for their sins, and this resulted in their having to leave their homelands. We understand that, in the first invasions of Assyria's armies, the two and onehalf tribes living east of the Jordan River were indeed taken into capoutside of the borders of Assyria. Many of Ephraim and the half

tribe of Manasseh moved south and settled in the land of Judea. Scripture says that only a few thousand remained in the land and that those few who lived through the final battle went into captivity. But, again, it does not say that even they suffered persecutions.

As mentioned earlier, Scripture shows that Armstrong was a "false prophet," and those who continue his false teachings are

future. If it is called false, it remains false.

That is no different today. If Armstrong and his followers continue to teach false prophecies, there will never come a time when their prophecies will come to pass. Israel's peoples will not be invaded by foreign armies, such as a revived Roman Empire. Israel's peoples will not go into captivity.

Yes, just as Israel was punished for their sins in the past, so will they be punished for their sins in the future. Yes, they will once

n Part 1 (at the top of this page), I point out that the end-time prophecies that have been made in our recent past have, to date, almost all failed.

Actually, one could say "all have failed"—thus making those who uttered such predictions to be "false prophets."

I also note that those today who are continuing to propound such failed predictions are themselves "false prophets"!

I also encourage the readers to "Search, Study, Prove and Try" the Scriptures in order to *see* that "no failed prophecy ever became a 'True prophecy at a future time.' "

A false prophecy is always a false prophecy.

All who are students of Scripture need to realize the meaning and intent of what it entails to Truly follow Scripture entails. Israel will indeed be punished for their sins, but not in the ways that the false prophets have been saying.

Note what is said to those who are to be the True prophets prior to the destruction of the nations of Israel as we see them today:

Ezekiel 2:4-5: "For they [Israel] are impudent children and stiff

hearted. I send you to them, and you shall say to them, Thus says Adonai YeHoVeH [No. 3069, not YeHoVah, No. 3068].

"And they, whether they will hear [or not], . . . yet shall they know that there has been a prophet among them!"

This means that, even though True prophets speak True predictions, as a general rule few will believe and accept their words John the Baptist. Both Scripture and history show that the author of the "prophetic" Book of Revelation was indeed this very John: John the Baptist. The only "proof" outside of Scripture, and recorded in history, that John the apostle wrote this book does not appear until the mid to late 300s AD. Even then, when Augustine, bishop of North Africa, finally "forced" Rome to make our pres-

ishment" will be but the "first step" in that which is generally referred to as the "end times."

I will paraphrase for brevity. But, if further understanding and clarifications are desired by readers, then that path is certainly open, for there is much understanding that can be added.

There will be an incredible "earthquake" of such great magnitude that mountain ranges degree that nothing on the earth will be able to grow: no foods for man or beast. Famine will become widespread.

But, again, for this time, famine will spread only over the lands of Israel in the latitudes of the north areas. The Scandinavian countries, Britain, Canada and perhaps the northern areas of the United States will be deeply affected.

The Israelite peoples who live in the southern latitudes (Australia, New Zealand and South Africa) will also be punished at this time, but in a different way that will be shown later.

However, though those in the south will have to leave their present homelands, Scripture does not say that they will be those who will migrate as a result of the famine taking place in the north.

The above is well documented in Scripture. As I mentioned earlier, the coming work of the Philadelphia church will make these scriptural facts well known to the chosen peoples, thus allowing the great numbers of millions to escape when the troubles actually begin.

In Part 3, I will begin to cover the "scriptural specifics," of that which I have given only an introductory overview.

prophetic statement that with His "death" world judgment would begin. Satan no longer was allowed to enter heaven (John 12:31). Satan and one-third of his angels had to leave heaven. The Savior, by His "death," is The Body Prepared by God to pay for the sins of the world (Hebrews 10:5).

Scripturally, Jesus clearly defines The Last Days: "Yet a little while is the light [of Truth] with you. Walk while you [disciples] have the light, lest darkness [without truth] come on you:

for he that walks in darkness knows not were he goes. While you have light, believe in the light [truth] that you may be the

children of light" (John 12:35-36). How wonderful and simple.

Before Jesus came to give "grace" [pardon] and "truth," The Prophets preached The Gospel of The Kingdom of God (John 1:17). When The Messiah came, He became more than The Prophets to give "grace" and "truth" after The Order of Melchizedek. When Israel and The Jews were taken captive, it was their Last Days to find "the truth." The Prophet Joel proclaimed it was a day of thick darkness. Israel rejected God and, then, they were on their own, not knowing what to do. The Last Days are not "the days" for The Kingdom of God to come, but for you to know "the truth" of The Kingdom of God. These are The Last Days.

Well, when will The End of Days come?

End of Days

The End of Days does not refer to one particular event but many events. The word "Days" in

Hebrew means "to time not necessarily as a clock clicks as twenty-four hours a day." But, with God, as Peter said, a day can be 1,000 years or just counted and regarded as one day. "Time" with God is "any age or a series of events." The First Day, in *The Book of Genesis*, "was counted" on The Clock of God as "an evening to a morning." That "evening to morning" could have been a thousand earthly years, a day or even eternal.

Daniel, The Prophet and Friend of God, called God The Ancient of Days (Daniel 7:13). Ancient

of Days is open-ended both from its past and its future.

End of Days includes many *Biblical* events which will hap-

pen in the future and are historical. "The End of Days" should be considered as "the end of an age" or "ages."

The First Day in Genesis could have been a thousand earthly years, a day or even eternal.

End of Time

Yes, The End of Time can refer to many ages, as well. The Aztecs, The Mayans and other cultures speak of The End of Days including The End of Time. The Mayans' End of Days, specifically, foretold the end of Esau's time and the beginning of Jacob–Israel's age or time. Jacob–Israel, will become first and not The Gentiles, who will complete their time or days. Mathematically it is who is first, last or last, first. It is not the end of the world in any of the cultures, prophetically. They all believe in a restructuring of The Earth by God, as He did in The Days of Peleg (Genesis 10:25), but it is not the destruction of the world.

The Messiah. He will begin The Millennium with The Kingdom of God ruling on the earth. The Last Days, end of the age or The End of Time are involved with many events. The Intended Purpose of God for specific conditions and events to transpire will be according to The Pleasure of God—declaring The End from The Beginning and from ancient times (by The Prophets) the things that are not yet done

(prophecy), saying, "My Counsel [God] shall stand and I will do all my [God's] pleasure" (Isaiah 46).

For God to reproduce Himself as 'All In All,' He must give you absolute 'liberty' to decide if you want to follow God.

God's Pleasure

Paul writes to The Saints and The Faithful that God has predestined (self-counsel) for the world to become Sons of God (Ephesians 1), "Having made known to you the mystery of his will, according to his good pleasure which he [God] has purposed in himself" (Ephesians 1:9), "That in the dispensation [distribute—come to pass] of the fulness [all fulfilled] of times [last age, time] he might gather [potential] together in one [like God, Genesis 1:26] all things in Christ [the mystery], both which are in heaven [spirits, men and angels] and which are on earth [dead and alive] even in Him" (Ephesians 1:10).

You have, prophetically, come to the time of The New Heavens and The New Earth, united as one, when God dwells with man and makes all things new (Revelation 21:5).

The Last Days, The End of Days and The End of Time cover different times as "ages," as last days. You need to know the prophecy and the history to place the context of what God is doing.

Free Choice

God, from the beginning, gave Adam and Eve free choice—"eternal life"—in Paradise. The alternative would be death. You have the same choice. That event is not timed like a clock but by conditional events.

For God to reproduce Himself so He can be "All In All," He must give you absolute "liberty" to decide if you want to follow God—or not

(Hebrews 1:1-3). You must have the same freedom to choose. God, also, wants to do whatever He chooses (I Corinthians 15:28). The Pleasure of God

comprises all of The Goodness of His "glory," which is your Hope of Glory, to be just like your loving Father (Colossians 1:27).

The Last Days or End of Time is prophetic rather than a certain time on a clock. Both The Last Days in each time frame and The End of Time are conditional and they are *Biblically* recorded. "Time" refers to "events" as ages, which can be forever.

The Bible covers many Last Days as well as The End of Time, but does not mean "the end of this earth."

It is all prophetic and in each case refers to a specific event. When this world has to be made new again (after World War III), The White Throne Judgment follows with a New Heaven and a New Earth.

It is all there—The Words of God and His "definitions" are all important words in *The Bible*. God will help you decipher all the clues so you will benefit in being able to live forever.

What does the Bible say about sex including homosexuality?

turn his instructions to the Corinthian church into universally applicable principles should be careful in how he proceeds.

Note that Paul regarded some of what he said as personal advice, not as a directive from the Lord (verses 6-8, 12).

We may reasonably conclude that nothing Paul wrote to the Corinthians should be interpreted to embellish or change Christ's clear instructions on these topics

If I'm right in this line of reasoning, Paul had no authority to override or modify Christ's statement on the

Jesus the conservative

Indeed, if we extract all of the statements on divorce in Scripture and compare them with each other, we find that Christ's "harsh" statement on the subject appear to be consistent with more of them than Moses' or Paul's "liberal" teachings.

God "divorced" Israel for adultery (Jeremiah 3:8). Malachi wrote that God makes a man and woman one and that He hates divorce (Malachi 2:14-16).

How do literal interpretations make you feel?

The great spiritual principle is clear: Man cannot nullify the marriage covenant. Only sin can dissolve it, according to God's standard.

How many of my fundamentalist friends will find such an interpretation of the scriptural teaching on divorce to be offensive?

Although these criteria will seem narrow and harsh to many of my readers (especially those whose current circumstances do not accord with the criteria), one could legitimately argue they are the standards Christ established for divorce.

Perhaps I have just succeeded in making some of my readers feel what homosexuals must experience when literal interpretations of Scripture are applied to them.

Nevertheless, lest we leave some of our readers in a state of despair and hopelessness, we should also note that the breaking of any of God's laws or standards can be repented of and forgiven.

"If we confess our sins, he is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness" (1 John 1:9).

Christ paid the penalty for all our sins and thus provided the means for our forgiveness.

Paul wrote that a person who has gone through the process of repentance and forgiveness emerges from it as a "new creature" and that all of his or her former sinful behavior is forgotten (2 Corinthians 5:17).

Christ indicated that the Samaritan woman (who had five husbands in her lifetime) still had access to the "living water" that only He could provide (John 4:4-26).

Brethren, there is always hope, even for those who have gone through a divorce.

Is homosexuality, per se, a perversion?

Before concluding this study of sex, I would be remiss not to address the topic of what constitutes perverse sexual behavior in the eyes of Almighty God.

As a student of the Bible for many years, I perceive that God's opinion of this subject is guided by the principles implied in the following questions:

- Does the behavior bring joy and happiness to both parties? (Matthew
- 7:12). Does the behavior harm anyone? (Romans 13:10).
- Is the behavior the product of two consenting equals? (Acts 10:34; Romans 10:12; Galatians 3:28).

Employing these criteria, we can see why rape, incest, prostitution, pedophilia and bestiality are properly regarded as perverse.

But what about homosexuality?

'All homosexual behavior is sin' not in Bible

In the sense that any transgression of the Law was considered a sin, the

act of homosexual intercourse could be considered such.

Leviticus 18:22 and 20:13 are part of what many refer to as the Law of Moses or Torah.

However, it will no doubt come as a shock to many of the readers of this article to learn that using these scriptures to label all homosexual behavior as sin is tantamount to twisting the Scriptures and distorting God's will in the matter.

God cannot be unfair

First, the scriptures in question describe the act of intercourse. They say absolutely nothing about sexual orien-

Why? First, because a general condemnation of homosexuality would make God unfair.

Science and personal testimony have demonstrated that human beings do not choose their sexual orientation.

It is true that the question of the roles played by nature and nurture in determining our orientation is unsettled, but the verdict is in on whether our orientation represents a conscious choice on our part. It does not.

In the same way that a heterosexual finds the opposite sex attractive without any conscious effort on his or her part, homosexuals find members of the same sex attractive.

Think about it. A sin is a conscious decision to choose a bad behavior over the good alternative. Hence the mere predisposition to find one sex more attractive or appealing than the other cannot be a sin.

Consulting mediums

Second, even though these scriptures are explicit about the act of homosexual intercourse, they are not superior to (or more enduring than) the other "laws" that are part of the same text.

Why is it appropriate to single out this law and ignore so many of the other ones?

- What about people who consult mediums? (Leviticus 20:6).
- What about someone who curses his mother or father? (verse 9).
- What about a man who has intercourse with a woman during the time of her monthly period? (verse 18).
- What about perverters of justice, those who discriminate against the poor or show favoritism to the rich and powerful? (Leviticus 19:15).
- What about a farmer who crossbreeds different kinds of animals or plants? (verse 19).
- What about people who wear cotton-poly- or poly-wool-blended clothing? (verse 19).
- What about the regulations governing skin diseases (Leviticus 13) and

I know of no one who argues in favor of the acceptance of gang rape. I am certainly not arguing for its accep-

According to the standard outlined above, gang rape would definitely be labeled as abominable and perverse.

Even so, what does "righteous" Lot do next? He offers his own virgin daughters to divert the mobsters away from the angels! (Genesis 19:6-8).

Is Lot's response appropriate? I, for one, would certainly not offer my daughters to a mob.

Was Ezekiel forgetful?

Does Scripture anywhere address the question of the sins of the two cities?

As a matter of fact, the prophet Ezekiel directly addressed the topic:

"Behold, this was the iniquity of thy sister Sodom, pride, fullness of bread, and abundance of idleness was in her and in her daughters, neither did she strengthen the hand of the poor and needy. And they were haughty, and committed abomination before me: therefore I took them away as I saw good" (Ezekiel 16:49-50).

Did Ezekiel simply forget to refer to homosexuality as one of their sins?

The sins of two cities

Likewise, other scriptures put the sins of the two cities into perspective relative to other people who have sinned.

Christ told His disciples that "it shall be more tolerable for the land of Sodom and Gomorrah in the day of judgment" than for the cities that would reject His disciples' missionary efforts (Matthew 10:14-15).

On another occasion Jesus said: "And thou, Capernaum, which art exalted unto heaven, shalt be brought down to hell: for if the mighty works. which have been done in thee, had been done in Sodom, it would have remained until this day" (Matthew 11:23).

"But I say unto you, that it shall be more tolerable for the land of Sodom in the day of judgment, than for thee' (verse 24).

Campaigns against Sodomites

Even so, some will still argue that homosexual behavior was a special case and that the Israelites were not even permitted to allow these people to live in their midst (Deuteronomy 23:17).

We also read in the accounts of the kingdom period that Asa, Jehoshaphat and Josiah launched major campaigns against the Sodomites within their

Paul spelled out 'vile affections'

Who was Paul talking about? Remember, context is an important part of properly understanding any scripture.

In the verses immediately preceding the passage quoted above, Paul wrote that God's wrath had been manifested against all of the wickedness and sin-



Even so, what if we were to allow that Paul intended his remarks as a general condemnation of homosexuality?

We would still be forced to contend with the context of the times and culture Paul was part of.

It is clear there was already a Jewish bias (Paul was a Jew) against homosexuality.

Remember, too, this is the same man who said women should not speak in church and that it was shame-

ful for a man to have long hair (1 Timothy 2:11-12; 1 Corinthians 11:14). Is it possible that cultural bias

intruded on Paul's writings on occasion? Taking into consideration the scriptures I just quoted, I believe it is certainly possible.

A homosexual's potential

A homosexual has the same potential for sinful or moral behavior as any heterosexual person.

Like their heterosexual counterparts, homosexuals are capable of pedophilia, incest, bestiality, prostitution, rape and promiscuity.

On the other hand, homosexuals are capable of love, fidelity, honesty, kindness and a host of other Christian

Almost any sexual behavior-heterosexual or homosexual—can result in idolatry, theft, infidelity, covetousness, etc., if indulged in with evil intent.

Determining God's will

Christians have espoused many erroneous notions about human sexuality and have presented them as if they originated in the mind of God.

It is apparent that some of those notions have found their way into the pages of the Bible. The contradictions and inconsistencies noted at the beginning of this article demonstrate that this has happened.

Therefore, when we evaluate the scriptural evidence in trying to determine God's will in the matter, the only safe way to proceed is by discerning broad principles that reflect God's character and intent in God's criteria for designating a behavior as deviant.

If a point or teaching is inconsistent with those broad principles, then it must be discarded.

Likewise, if a teaching is consistent with the overall understanding of the divine character, it should be retained.

God's will should be our standard, not what someone wrote about his or her perception of God's will in one or two instances.

Moreover, the standards of a culture extant on earth 3,000 years ago should not be adopted as God's standard or

Atheists, secularists, fundamentalists

In preaching this method for determining God's will, I think my most vociferous critics will be atheists, secularists and fundamentalists. They all look at the Bible as an all-or-nothing proposition.

Atheists and secularists look at the contradictions and inconsistencies in Scripture and reject it as having no value to inform us of God's will. Similarly, fundamentalists argue that

we must accept all of the teachings of Scripture—entirely dismissing or ignoring the glaring contradictions I have pointed out and reserving the right to exclude those portions of Scripture with which they happen to disagree.

In the end, fundamentalist Christians come to the same conclusion as atheists and secularists: If you can't believe it all, you can't believe any of it.

Satan has deceived the whole world (Revelation 12:9). This truth is nowhere more apparent than in the realm of human sexuality.

May God help us cease making what is good into something that is bad, shameful and dirty.

In preaching this method for determining God's will, I think my most vociferous critics will be atheists, secularists and fundamentalists. They all look at the Bible as an all-or-nothing proposition.

- What about people who like their meat cooked rare rather than well done? (verse 26).
- What about those guys who trim the sides of their beards? (verse 27).
- What about those monsters who get tattoos? (verse 28).
- Am I being ridiculous enough yet to demonstrate my point? I could go on.

What was the sin of Sodom and Gomorrah?

Why is it appropriate to ignore or dismiss all of these regulations and uphold the injunction against homosexual intercourse?

What about Sodom and Gomorrah? What was the sin of those cities? Why were they destroyed?

We all remember the story, but many of us have glossed over what was actually going on in the plain of

Our churches and preachers and traditions have told us the men of Sodom conspired together to attempt to gangrape the two angels God had sent to check up on the behavior of the city's

kingdoms (1 Kings 15:12; 22:46; 2 Kings 23:7).

Nevertheless, note in this connection that "Sodomite" was not synonymous with "homosexual" in Old Testament usage. The term in the original Hebrew refers to male prostitutes who were consecrated to Astarte or Venus (Strong's Exhaustive Concordance).

Thus, while we can agree that idolatrous prostitution could be viewed as a legitimate target for a righteous king, these scriptures do not have any universal application to homosexuals or their personal behavior.

Vile, unnatural

Even so, I understand that most traditionalists will still not want to let go of their antihomosexual bias. They will turn next to the writings of Paul in the New Testament.

In Paul's letter to the saints at Rome we read: "For this cause God gave them up unto vile affections: for even their women did change the natural use into that which is against nature" (Romans 1:26).

"And likewise also the men, leaving

Sinfully consumed

In other words, these folks had a lot of problems. They were consumed

Hence, it is misleading to make this scripture apply to all homosexuals. Paul was pointing to extremely wicked individuals who had turned their backs on God.

I acknowledge that Paul also lists male prostitutes and homosexual offenders among those who will not inherit the Kingdom of God (1 Corinthians 6:9). It is clear, however, that he was singling out homosexuals' "perverse" behavior (prostitution and promiscuity) as the object of his condemnation.

It is misleading to characterize this passage as a blanket condemnation of homosexuality. Likewise, Paul uses similar language in his letter to Timothy (1 Timothy 1:10).

Doris Cole of Tyler, Texas, who attended the reunion with her husband, Wayne, remembers Big Sandy's beginnings.

Farthest east

the investigators wrote.

So the tools are available and the time has come to put Anglo-Israelism to the test.

The theory traditionally used name markers as indicators of migration patterns, but now it's possible to use genetic markers to indicate population transfers across geographic boundaries.

À well-designed research project could produce results that would either buttress the theory or lay it to rest. Either result should be viewed as a positive outcome. If scientific results support the theory, great. If they do not, then the truth will set us free from error.
